The purpose is to create a new chapter to include retailer licensing provisions that are contained currently in Instant and On-Line Game Regulations. This chapter will include eligibility requirements, application procedures, bonding and bank account requirements, licensing terms and fees, retailer compensation, retailer standards of conduct, license denial or revocation, and audit of records.

The Lottery has determined that for simplification and understanding, the department regulations should be reorganized. The licensing regulations under consideration are essentially those that are contained currently in the Lottery's Instant Game and On-Line Game Regulations. Because of duplication of provisions in each of these chapters, all lottery retailer licensing requirements will be combined and restated under a single chapter.

Alternatives

No alternatives were considered because this new chapter will simplify the regulations and will provide more user-friendly application.
