This final exempt regulatory action is being taken to implement Chapter 220 of the 2011 Acts of Assembly. The regulation is being amended to address means by which discharges of sewage from boats and vessels will be prevented while in no discharge zones.

### Statement of final agency action

On August 4, 2011, the State Water Control Board took final action to adopt amendments to the regulation entitled " Regulations Governing the Discharge of Sewage and Other Wastes from Boats,"

specifically amending 9VAC25-71-60. The regulatory action will be filed as soon as possible, consistent with the Administrative Process Act.

The regulation amendments are exempt from the state administrative procedures for adoption of regulations contained in Article 2 of the Administrative Process Act by the provisions of § 2.2-4006 A 4 a of the Administrative Process Act because they are necessary to conform to Virginia statutory law.

60		Currently toilets are required to be removed from houseboats if the houseboat lacks a sewage holding tank. Through hull mechanisms for discharging sewage must be rendered inoperable while a boat or vessel is in a no discharge zone.	The regulation is being amended to revise the manner in which houseboats without sewage holding tanks are prevented from discharging while in no discharge zones. Toilets are not required to be removed from houseboats without a sewage holding tank; however, all boats and vessels are to prevent sewage discharges from marine sanitation devices in no discharge zones. Y-valves, macerator pump valves, discharge conveyances, and any other through-hull fitting valves capable of discharging sewage are required to be secured in the closed position while in a no discharge zone. Using a padlock or nonreleasable wire tie or removing the y-valve handle are methods that can be used to prevent sewage discharges from occurring in the no discharge zone. The method chosen shall present a physical barrier to the use of the y-valve or toilet. This regulatory change is needed as a result of changes made to § 62.1-44.33 of the Code of Virginia.

**Regulatory flexibility analysis**

Since the regulatory change is being made to conform to state law, the board does not have any discretion concerning alternative regulatory methods. State law specifies the methods that shall be used to prevent sewage discharges from occurring in no discharge areas. The statutory change and corresponding regulatory change does however provide more options for houseboats, boats and vessels. Previously houseboats without holding tanks were required to have their toilets removed if the houseboat was located in a no discharge zone. This regulatory change no longer requires the removal of toilets from houseboats. Houseboats, boats and vessels located in no discharge zones are subject to the same rules concerning how sewage discharges will be prevented. The goal of the regulation is to prevent sewage from being discharged in no discharge zones.

The regulatory change may benefit small businesses. Toilets will no longer be required to be removed from houseboats without holding tanks and some small businesses may own these types of boats. The other methods described in statute and regulation are likely less expensive options to prevent sewage discharges from boats and vessels in no discharge zones.

No reporting requirements are associated with the requirement to not discharge sewage from boats and vessels in no discharge zones.

Since state statute applies to all documented and undocumented boats and vessels, small businesses are unable to be exempted from the requirements of these regulations.

### Family impact
