The amendments to Chapter 180 are being made in order to change the Lasix administration time for race meets where the horses are shipped in to race as opposed to being stabled on the grounds of a racetrack and also to provide for the retainage of split samples by the official testing laboratory.

On April 8, 2015, the Virginia Racing Commission adopted the final amendments to 11VAC10-180-10 (Definitions), 11VAC10-180-25 (Veterinary practices), 11VAC10-180-35 (Prohibited practices), 11VAC10-180-70 (Phenylbutazone, flunixin and other NSAIDs), 11VAC10-180-75 (Androgenic and anabolic steroids), 11VAC10-180-80 (Permitted race day substances), 11VAC10-180-85 (Bleeders), 11VAC10-180-90 (Bicarbonate testing), and 11VAC10-180-110 (Laboratory findings and reports) at its regular monthly meeting.
