The Virginia Hazardous Waste Management Regulations, 9VAC20-60, include citations and requirements in the form of incorporated federal regulatory text at Title 40 of the Code of Federal Regulations (CFR). This regulatory amendment will bring these citations up to date and incorporate the latest Title 40 of the CFR to the one as published in the July 1, 2015 update.

As part of this regulatory action, the Board is adopting EPA's Definition of Solid Waste (DSW) as promulgated on October 30, 2008 and subsequently updated by the Revisions to the Definition of Solid Waste Rule promulgated on January 13, 2015 (80 FR 1694). The purpose of the DSW rule is to ensure that the hazardous secondary materials recycling regulations, as implemented, encourage reclamation in a way that does not result in increased risk to human health and the environment from discarded hazardous secondary material. However, Annual Update 2015 will not incorporate the conditional exclusion for hazardous secondary materials that are managed in land-based units. This regulatory action amends the definition of "contained" to add condition (5) which clarifies that land-based units managing hazardous

secondary materials will continue to be required to comply with the applicable provisions of the VHMWR for hazardous waste land-based units.

Section 2.2-4006 A 4 (c) of the Code of Virginia allows the Board to adopt this regulatory amendment to 9VAC20-60 as the changes are necessary to conform to changes in the federal regulations. This regulatory amendment will be effective 30 days after publication in the *Virginia Register*.

Statement of final agency action

The Virginia Waste Management Board approved this amendment, Annual Update 2015, to 9VAC20-60 on December 4, 2015 as a final regulation and affirmed that the Board will receive, consider and respond to requests by any interested person at any time with respect to reconsideration or revision.

This amendment will incorporate the final federal rules for: (i) the Definition of Solid Waste Rule (73 FR 64668) as updated by the Revisions to the Definition of Solid Waste (80 FR 1694); (ii) the Vacatur of the Comparable Fuels Rule and the Gasification Rule (80 FR 18777); and, (iii) the

		changes to 40CFR261 which are a part of the Disposal of Coal Combustion Residuals from Electric Utilities (80 FR 21302).
9VAC20-60-260	Adoption of 40 CFR Part 260 by reference.	Under subdivision B.2, modified the adoption of 40 CFR Part 260 to amend the definition of "contained". The DSW's less stringent requirements for the definition of "contained" includes a conditional exemption for land-based units managing hazardous secondary materials. Condition (5) has been added to the term contained to clarify that land-based units that manage hazardous secondary materials will continue to be required to meet the applicable VHWMR provisions for a hazardous waste land- based unit.
9VAC20-60-261	Adoption of 40 CFR Part 261 by reference.	Deleted Subdivision B.8 as the definition of solid waste rule and its subsequent revised rule are now being incorporated into 9VAC20-60.
9VAC20-60- 1390	Changes in Classifications As a Solid Waste.	Added the DSW's 40CFR260 provisions for variance and non-waste determination including conditions under which a variance could be considered a hazardous secondary material to this section.
9VAC20-60- 1420	Administrative Procedures.	Added the DSW's 40CFR260 provisions for variance and non-waste determination processing, term and notifications required to this section.

Conforming state regulations to those of the EPA is necessary to maintain federally-granted authority to implement the national programs. Facilities benefit from state implementation of the program as they have easier access to decision makers with a clearer understanding of state-specific issues and needs.
