Purpose

The purpose of the proposed action is to repeal the regulation concurrently with the promulgation of a new regulation (22 VAC 45-51). The current regulation was last revised in 1990 and requires revisions to ensure consistency with federal regulations. New regulation adds detailed federal citations for State Vocational Rehabilitation Services Programs and removes agency policy language and two duplicative sections that are referenced in other sections of regulation according to federal citations. Overall, the proposed new regulations update the existing regulations.

The regulation will include the agency name change and replacement of agency policy language with regulatory language derived directly from the federal regulation (34 CFR Part 361.)

New regulations provide clearer articulation of vocational rehabilitation regulations for citizens who are blind or vision impaired.

Detail includes:

- 1. Change of agency name from Department for the Visually Handicapped to Department for the Blind and Vision Impaired throughout.
- 2. Updates state definitions to accurately reflect federal definitions.
- 3. Clarifies the addition of referrals of individuals made through the One-Stop service delivery systems established under section 121 of the Workforce Investment Act of 1998.
- 4. Adds presumption of eligibility for services for individuals who are receiving SSI/SSDI as reflected in federal regulations.
- 5. Clarifies Order of Selection for services.
- 6. Removes agency policy language related to scope of services and adds federal citations for scope of services.
- 7. Removes agency policy language related to the Individualized Plan for Employment (IPE) and adds detail from federal citation.
- 8. Removes agency policy language related to rates of pay.
- 9. Removes agency policy language related to participation in cost of services.
- 10. Expands review of agency determinations to reflect federal regulations and changes the name of the Department for the Rights of Virginian's with Disabilities to the Virginia Office for Protection and Advocacy.
- 11. Expands state regulation to include federal citation regarding periodic review of extended employment in nonintegrated settings and ineligibility closures.

DBVI administration considered revision of existing regulations but found changes to be substantial.
