During the public comment stage, the Department of Forestry conducted two different public input opportunities. The first proposed stage sought the public's input on lifting the prohibition against lawful concealed firearms with a valid permit while retaining the prohibition against open - carried firearms. Due to overwhelming level of requests to remove the prohibition against both lawful concealed and open - carried firearms, the agency submitted a second but revised amendment for public input.

Current State Forest regulations prohibit individuals from carrying any firearms onto State Forest properties unless exempted because of lawful hunting seasons. The final regulatory amendment would allow persons to carry lawful open and concealed firearms onto State Forest properties under the ownership and management of the Department of Forestry.

The Department of Forestry will amend regulation 4 VAC 10- 30 – 170, State Forest Regulations, to remove the prohibition against the carrying of firearms onto State Forest properties. The regulation will become final following the conclusion of a thirty day publication period in the Virginia Register, providing that lawful actions don't delay the process.

Legal basis

Section 10.1-1101 of the Code of Virginia provides the Department of Forestry, with the approval of the State Forester, the authority to promulgate regulations necessary or incidental to the performance of duties or execution of powers conferred under Chapter 11 (§ 10.1-1100 et seq.) of Title 10.1 of the Code of Virginia.

Purpose

The right to bear arms is protected by the second amendment to the Constitution. Citizens have requested the Department of Forestry remove the prohibition against carrying firearms within State Forests because they believe this action is necessary to protect their health, safety, and welfare against violent people and wild animals.

The Virginia Citizens Defense League petitioned the Department of Forestry (DOF) for a ruling to amend 4VAC10-30-170 and eliminate the prohibition against both open carried and concealed firearms. DOF completed its response to the petition and began the process of amending its regulation with the intent of removing the prohibition against lawful concealed firearms and continuing the prohibition on open carried firearms. DOF completed the Notice of Intended Regulatory Action (NOIRA) and first public comment stages. DOF received 1,926 comments during the NOIRA stage, and 2,409 comments supporting the amendment during the first proposed stage. Based on the volume of comments from the first public comment stage (February 15, 2010, through April 16, 2010) supporting the lawful carrying of both open and concealed firearms on state forests and a review of Virginia statutes, DOF proposed a second public comment stage and a new proposed regulation to allow the lawful carrying of open and concealed firearms on state forests.

During the second proposed stage for public comment, the Department of Forestry received 1094 comments total. 1087 comments showed strong support the amendment to allow both the carrying of lawful open – carried and concealed firearms in State Forests. Five comments

indicated strong non - support of the amendment. Two comments only addressed questions about the impact of the amendment.

The final regulatory amendment will reflect the agency's desire to remove the prohibition and allow the lawful carrying of open – carried and concealed firearms on State Forests. Two formal public comment stages indicate strong support for the final amendment. In addition, the Office of the Governor is in support of the final regulatory amendment.

Substance

The agency will change its regulation, which currently prohibits the carrying of firearms onto state forests, except for lawful hunting, to allow persons to carry lawful open carried and concealed firearms onto state forests.

Citizens are allowed by the Code of Virginia to carry lawful open carried firearms, as well as concealed firearms with a valid permit, in Virginia. The Department of Forestry is not authorized under the Code of Virginia to regulate firearms on State Forests. The state forest regulation amendment will be in harmony with Virginia law and ensure that law abiding citizens will not violate a regulation that carries a Class 4 misdemeanor penalty.

The Virginia Citizens Defense League requested DOF to amend 4VAC10-30-170 to lift the prohibition against carrying lawfully open carried and concealed firearms on the state forests. During the first public comment phase from February 15, 2010, through April 16, 2010, DOF received a large number of comments in support of both lawful carrying of open and concealed firearms on state forests. DOF completed a second public comment period of 30 days to reflect a regulatory amendment that will allow the lawful carrying of both open and concealed firearms. This amendment allows persons to carry lawful open carried and concealed firearms onto state forests at any time.

The Virginia Department of Planning and Budget conducted an Economic Impact Analysis and concluded in their report that no known disadvantages to the public could be discerned through their analysis. The following quote is from the DPB's Economic Impact Analysis Report dated December 15, 2010. "This change will allow individuals to have the protection of a weapon in state forests which will likely provide a benefit for them as well as any other unarmed citizens that might receive ancillary protection from crime or animal attack. It is very unlikely that any

individual would suffer costs from increased crimes on account of this change because concealed carry holders appear to commit far fewer crimes than individuals that don't hold concealed carry permits. There appear to be no studies that attempt to measure any negative impact of open carry on unarmed individuals but anecdotal evidence suggests that such impact would be minimal to nonexistent."

The <u>first</u> proposed stage showed that most supporting commenters were interested in individual rights, second amendment, government authority, and previous Virginia Attorney General opinions in addition to their written support of the amendment to allow concealed handguns. Even though 1134 comments did not mention open carry, many of these comments indicated the State Forester was not authorized to regulate the carrying of firearms on State Forests.

During the first proposed stage, six commenters did not support the amendment. The most common reasons given for this position were the impact on family use of these spaces and the potential for discharge of weapons.

The <u>second</u> proposed stage amended the language submitted in the first stage to indicate the strong support to allow the carrying of lawful open – carried and concealed firearms in State Forests. The second proposed stage is consistent with the Code of Virginia and has the support of the Governor of Virginia.

During the second proposed stage, DOF received a total 1094 comments. 1087 comments supported the amendment to allow the carrying of open – carried and concealed firearms in State Forests. Most comments pointed out the Constitutional right granted under the Second Amendment, safety for themselves and families. Many supporters stated that law abiding citizens should be able to protect themselves from dangers and risks associated with forest lands.

Five commenters did not support the amendment and questioned the need for allowing firearms in State Forests. Some questioned the impact on tourism.

The Department of Planning & Budget addressed these issues in its Economic Impact Analysis dated December 15, 2010. The following results were reported and the Department of Forestry concurs with the findings of the DPB Economic Impact Analysis. The amendment to the State Forest regulations will remove the prohibition against the lawful carrying of open and concealed firearms in State Forests. By adopting the final regulation, the agency's regulations will be in full compliance with the Code of Virginia.

Businesses and Entities Affected

This proposed regulatory change will affect all individuals who visit, or travel in, state forests.
