The payments that are ending were made to the following hospitals: Prince William, Culpeper, Haymarket. The hospitals have been consulted and agree with the change.

The purpose of this action is to sunset these supplemental payments so that broader-based inpatient and outpatient hospital supplemental payments can be established. The new payments will apply to a larger number of hospitals.

Rationale for using fast-track process

This regulatory action is being promulgated as a fast track action because it is expected to be non-controversial. DMAS has consulted with the affected hospitals and they have agreed to the termination of these supplemental payments.

Substance

In order to avoid overlapping inpatient and outpatient supplemental payments, supplemental payments made to a limited group of private hospitals are being terminated on the date that new supplemental payments are effective. The three hospitals will be eligible to receive the new supplemental payments.

The following supplemental payments will be sunset in this regulatory action: supplemental inpatient and outpatient payments for private hospital partners of Type One hospitals (Culpeper, Haymarket and Prince William). The University of Virginia Medical Center is a minority owner in these hospitals and has been making an intergovernmental transfer to fund the non-federal share of the supplemental payments. The intergovernmental transfer will no longer be needed after this regulatory action.

The three hospitals affected are in Culpeper, Fauquier, and Prince William counties. On other regulatory actions, DMAS will be establishing alternative supplemental payments for all qualifying private acute care hospitals including these three.
