On July 1, 2013 and pursuant Chapter 803 and Chapter 835 of the 2012 *Acts of Assembly*, Adult Services and Adult Protective Services Programs were relocated from the Department of Social Services to the Department for Aging and Rehabilitative Services (DARS) which was created pursuant to § 51.5-117 of the Code of Virginia. This change is a result of the Governor's reorganization of the executive branch of state government.

In section 10 of the Adult Services Approved Provider regulation, the definition of "Department" was changed from "Department of Social Services" to the "Department for Aging and Rehabilitative Services." Additionally the phrase "Department of Social Services" was stricken in the definition of "local department approved provider."

In section 50 "department" was changed to "Department of Social Services."

In section 150, "State Board of Social Services" was stricken and replaced with "the Commissioner for the Department for Aging and Rehabilitative Services" as the Commissioner of DARS has the authority to

promulgate and oversee regulations related to adult services. Also in section 150 "Department of Social Services was stricken from the sentence that referenced the Adult Protective Services hotline.

Because portions of this regulation are implemented by the local department of social services, many references to these local departments remain throughout the regulation.

Because this regulation is now being promulgated by a different agency, the agency and chapter numbers for each section of the regulation have been changed. Also, the Code of Virginia citations, which authorized each section of this regulation to be promulgated, have been changed to the appropriate DARS Code of Virginia citation.

## Statement of final agency action

On October 9, 2013, the Commissioner of the Virginia Department for Aging and Rehabilitative Services will adopt these amendments to the existing regulations entitled Adult Services Approved Providers (22 VAC30-120 et seq.) as a regulatory action exempt from the Administrative Process Act under §2.2-4006 of the Code of Virginia.
