This regulatory action will amend a regulation section entitled "Passport Denial Program" to provide an additional exception for a noncustodial parent's release from the program. Currently, there is one exception for "compelling evidence of a life-or-death situation of an immediate family member."

The amendment will add an exception for release from the passport program if a noncustodial parent provides documentation from the employer to verify that the employment requires international travel.

This regulatory action will amend a regulation section entitled "Passport Denial Program" to provide an additional exception for release of a noncustodial parent's passport.

This amendment is needed to provide the Division of Child Support Enforcement (Division) with the ability to increase collection of child support for families. Currently, noncustodial parents in the Passport Denial Program must pay their child support arrears in full to obtain or renew a passport. The only exception is for cases where a noncustodial parent's immediate family member lives abroad and faces a life-or-death situation. In those instances, the Division director can grant the release of a passport upon the noncustodial parent's written request, which must include documentation of compelling evidence of the situation.

With our increasingly mobile society, many child support payors need to travel internationally for work. Under the current regulation, these noncustodial parents have no way to obtain or renew their passport unless they have the ability to pay their arrears in full. The Division would like to encourage payment of support and does not want the passport regulation to be a barrier when a noncustodial parent has

DSS does not believe that the proposed regulation will be controversial. The amended regulation will provide for an additional exception for release of a passport from the Passport Denial Program.

Substance

This regulatory action will amend an existing regulation section entitled "Passport Denial Program" to provide for an additional exception for a noncustodial parent's release from the Passport Denial Program.

This change would enable the Division to work with noncustodial parents who are unable to pay their child support arrearage in full but whose employment is contingent upon international travel to allow them to obtain or renew their passport. These parents would be required to make a lump sum payment towards their arrearage, agree to an income withholding order, and enter into a payment agreement with the Division with a regular monthly payment amount and a schedule for paying off the arrearage in full. They would also be required to provide written proof of current employment or proof of an offer and acceptance of employment from their employer.

There are numerous advantages to this regulatory action. The amended regulatory section will (1) provide an additional exception for a noncustodial parent's release from the Passport Denial Program in Virginia; (2) increase child support collection through lump sum payments and payment agreements; and (3) potentially provide for regular payment of support from noncustodial parents who are required to travel internationally as part of their employment.

DSS is aware of no disadvantage to this regulatory action.

The purpose of this regulatory action is to provide an additional exception for a noncustodial parent to be released from the Passport Denial Program. The program was implemented in Virginia in 1997. In SFY2016, the Division collected \$144,735 from parents who were in the program and wished to obtain or renew a passport.

As an alternative to the proposed language of the new regulatory section, the Division could request the release of a noncustodial parent from the Passport Denial Program prior to satisfying the arrearage. However, the Division has determined that releasing a noncustodial parent from the program before he or she satisfies the arrearage may negatively impact the custodial parent and ultimately the children for whom support is owed. It would be difficult, and in many cases impossible, for DSS to assist custodial parents owed current support or arrears should the noncustodial parent leave the country with a valid passport but without having an income withholding order and payment agreement with the Division.

This regulatory action will not impact small businesses.

This fast-track is not the result of a periodic review/small business impact review.

Family impact

This regulatory action will not negatively impact the rights of noncustodial parents with regard to their children. Should the noncustodial parent need his/her passport for economic reasons, it can be obtained by (1) satisfying the arrearage or (2) providing proof of employment that requires international travel, making a lump sum payment towards the support arrearage, agreeing to an income withholding order, and entering into a payment agreement with the Division. This regulation will not impact marital commitment. The Passport Denial Program will not impact disposable family income. The arrearage which must be satisfied prior to release from the program is only composed of ordered child support payments which were not previously paid.

Release from the Passport Denial Program can also occur with proof of a life-or-death situation of an

immediate family member.
