The State Board of Social Services took final action on 22VAC40-12, Public Participation Guidelines, on August 16, 2017.

The proposed amendment merely conforms the agency's Public Participation Guidelines regulation to § 2.2-4007.02, there is no alternative regulatory method. The proposed amendments may serve to ease the burden on those wishing to provide input into regulatory development

Notice of periodic review was published May 29, 2017, with public comment ending June 19, 2017. While no comments were received, amendments are needed to Section 50 in order to conform the regulation to the Code of Virginia.

The regulation meets the criteria set forth in Executive Order 17 (2014) and is necessary to ensure adequate opportunities for public participation in the regulatory process. No complaints have been received, the regulation is straight-forward and does not overlap, duplicate or conflict with other laws and regulations. The regulation was last evaluated in 2012.
