Purpose

The Regulations Governing Educational Services for Gifted Students were last approved in 1993, with an effective date of February 1995. Those regulations specify what gifted education services school divisions in the Commonwealth of Virginia shall provide students from kindergarten through graduation. The regulations speak to the area(s) of giftedness to be served, the identification of students in the selected area(s) of service, the criteria for screening and identification, the components of local plan that each division must have approved by the Department of Education, the assurances the school division must provide to the department regarding elements within the local plan, and provisions of use of state funds designated for division-wide gifted education services. The proposed revisions will allow the Virginia Board of Education to review contemporary research and best practices in the field that have occurred in the last decade and to ensure that Virginia's regulations are consistent with that information.

- 1. Changes to the definition of "gifted students," to include contemporary language and definitions. Additional definitions to assist divisions in program design and evaluation may be incorporated into the revised regulations.
- 2. Language will be added to 8VAC20-40-60. Local Plan. that will assist divisions in developing and evaluating their service options, instructional approaches, settings, and staffing as well as to the framework of appropriately differentiated curriculum to be used in those settings.
- Changes in language for the selection and evaluation of teachers as well as the training needed for those professionals to develop, present, assess, and revise curriculum used with these students.
- 4. Changes in language regarding program evaluation may be supplemented with specific expectations and timelines for evaluative components.

Alternatives

The proposed action is to amend existing regulations. The current regulations should be revised for clarity and to ensure that there are no conflicts with existing Board of Education regulations and state law. There are no viable alternatives.

The regulations have served well for more than ten years and have been supplemented through information presented in the *Virginia Plan for the Gifted* and the *Reference Guide for the Development and Evaluation of Local Plans for the Education of the Gifted.* Both documents demonstrate that the regulations are outdated and need to be revised.
