#1. Legislative Report – Elaine Yeatts

Ms. Yeatts informed the Advisory Board of bills of interest from the 2013 session of the General Assembly. No action was required.

2. Review of Regulatory Revisions – Elaine Yeatts

As part of the Governor's Regulatory Reform Project, Ms. Yeatts reviewed the regulations governing the practice of radiologic technology with the Advisory Board to determine if any regulations could be revised or repealed. Ms. Yeatts reviewed and discussed with the Advisory Board the following changes recommended by Board staff:

- "NMTCB" means the Nuclear Medicine Technology Certification Board" will be included within 18VAC85-101-10 Definitions.
- 18VAC85-101-40(3) & (C) include "or NMTCB exam" after ARRT.
- 18VAC85-101-55(A)(1) the phrase "successful completion of a program" will be replaced with "successful completion of educational coursework."
- 18VAC85-101-60(1) the words "on patients" will be included after the word "pelvis."
- 18VAC85-101-60(3) the words "on patients" will be included after words "10 radiologic examinations."
- 18VAC85-101-60(C)(1)(a) the words "on patients" will be included after the words "successfully performed."
- 18VAC85-101-61(C) the clause "if training for limited licensure in bone densitometry or abdomen and pelvis" will be repealed. Further, "radiologic examinations," will be included after the words "completion of the required number of" and "procedures" will be deleted.

• 18VAC85-101-130(B) the word "instill" is deleted and replaced with "administer" and "or radiopharmaceuticals" is included after the words "contrast media," and "during radiologic examinations" is deleted.

Dr. Konerding made a motion to take fast-track action to amend the regulations governing the practice of radiologic technology recommended by Board staff. The motion was seconded and carried.
