- Within 60 days of the entry of this Order, shall provide evidence of publishing the NCLEX passage rates for the entire history of the program, by quarters and calendar years (or year-to-date for the current year);
- 4. Within 60 days of the entry of this Order, shall provide evidence of publishing a statement that continued program approval by the Virginia Board of Nursing requires an annual NCLEX passage rates for first-time test takers of 80% or above;
- 5. Within 60 days of the entry of this Order, shall provide a copy of the Order to all current and prospective students; and
- 6. Within 60 days of the entry of this Order, shall provide evidence of faculty involvement in curriculum design, implementation, teaching, evaluation, and revision at the Virginia Beach campus.

Following the receipt of the evidence, the Board will review and consider this information and the program approval status at an informal conference.
