Dear Mr. Justice:

An informal hearing was held on September 19, 2014, to review the issuance of all Notices of Violation specified on the Attachment A. Based upon the attached opinion of the Informal Hearings Officer, I am affirming the issuance of all captioned violations. Due to the time it has taken to research this issue and render an opinion, I have instructed that the NOVs be modified to allow the company thirty days from this decision to submit the replacement performance bond.

Pursuant to §4VAC25-130-843.16(a) of the Virginia Coal Surface Mining Reclamation Regulations, you (or any person having an interest which is or may be adversely affected by this decision) have the right to request a formal public hearing to review this decision.
