Chapter 82 of the 2016 General Assembly requires health regulatory boards to promulgate regulations to allow some volunteer service time to count towards meeting some of a licensee's continuing education requirements.

The Board has adopted proposed regulations to allow dentists and dental hygienists to count up to two hours of the 15 hours required for annual renewal to be satisfied through delivery of dental services, without compensation, to low-income individuals receiving health services through a local health department or a free clinic organized in whole or primarily for the delivery

of those services. One hour of continuing education may be credited for three hours of providing such volunteer services, as documented by the health department or free clinic.

In addition, the Board is including provisions for granting an extension of the continuing education requirement for up to one year upon written request with an explanation received prior to the renewal deadline.

On June 10, 2016, the Board of Dentistry adopted amendments to 18VAC60-21-10 et seq., Regulations Governing the Practice of Dentistry and 18VAC60-25-10 et seq., Regulations Governing the Practice of Dental Hygiene.

Regulations are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Section 54.1-2400, which provides the Board of Dentistry the authority to promulgate regulations to administer the regulatory system and a specific mandate of Chapter 82 of the 2016 General Assembly:

§ 54.1-2400. General powers and duties of health regulatory boards.

The general powers and duties of health regulatory boards shall be:

1. To establish the qualifications for registration, certification, licensure or the issuance of a multistate licensure privilege in accordance with the applicable law which are necessary to ensure competence and integrity to engage in the regulated professions.

2. To examine or cause to be examined applicants for certification or licensure. Unless otherwise required by law, examinations shall be administered in writing or shall be a demonstration of manual skills.
3. To register, certify, license or issue a multistate licensure privilege to qualified applicants as practitioners of the particular profession or professions regulated by such board.
4. To establish schedules for renewals of registration, certification, licensure, and the issuance of a multistate licensure privilege.
5. To levy and collect fees for application processing, examination, registration, certification or licensure or the issuance of a multistate licensure privilege and renewal that are sufficient to cover all expenses for the administration and operation of the Department of Health Professions, the Board of Health Professions and the health regulatory boards.
6. To promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) *that are reasonable and necessary to administer effectively the regulatory system, which shall include provisions for the satisfaction of board-required continuing education for individuals registered, certified, licensed, or issued a multistate licensure privilege by a health regulatory board through delivery of health care services, without compensation, to low-income individuals receiving health services through a local health department or a free clinic organized in whole or primarily for the delivery of those health services.* Such regulations shall not conflict with the purposes and intent of this chapter or of Chapter 1 (§ 54.1-100 et seq.) and Chapter 25 (§ 54.1-2500 et seq.).

The statutory authority for granting an extension for completion of continuing education hours is found in Chapter 27 of Title 54.1:

§ 54.1-2709. License; application; qualifications; examinations.

E. The Board shall promulgate regulations requiring continuing education for any dental license renewal or reinstatement. The Board may grant *extensions* or exemptions from these continuing education requirements.

§ 54.1-2729. Continuing education.

The Board shall promulgate regulations requiring continuing education for any dental hygienist license renewal or reinstatement. The Board may grant *exceptions* or exemptions from these continuing education requirements.

Purpose

The purpose of the amended regulation is compliance with the mandate of the General Assembly and to provide an incentive for licensees to volunteer professional services to free clinics or public health centers. While a licensee can satisfy up to two hours of continuing education with six hours of volunteer service, he or she is still required to have 13 hours of approved continuing education necessary to acquire new knowledge and skills. Therefore, public health is served by a potential increase in badly-needed volunteer service for dental care; but public safety is not sacrificed by eliminating most or all of the continuing education hours required for renewal.

Rationale for using fast-track process

The allowance of hours for volunteer service to be counted towards the continuing education requirement is a mandate of the General Assembly. A licensee is not required to provide volunteer service but may be credited with continuing education hours for doing so. The provision for an extension of hours is a benefit to licensees who may have reasons for needing additional time for completion of the requirement. Both provisions are permissive and neither is controversial.

Substance

To comply with the mandate of Chapter 82 of the 2016 General Assembly, the Board has adopted a proposed regulation to allow dentists and dental hygienists to count up to two hours of the 15 hours required for annual renewal to be satisfied through delivery of dental services, without compensation, to low-income individuals receiving health services through a local health department or a free clinic organized in whole or primarily for the delivery of those services. One hour of continuing education may be credited for three hours of providing such volunteer services, as documented by the health department or free clinic.

In addition, the Board is including provisions for granting an extension of the continuing education requirement for up to one year for good cause and upon written request received prior to the renewal deadline.

Issues

- 1) The advantage to the public is the incentive given for dentists and dental hygienists to volunteer their services in exchange for credit towards meeting continuing education requirements. There are no disadvantages.
- 2) There are no advantages or disadvantages to the agency or the Commonwealth.
- 3) The Director of the Department of Health Professions has reviewed the proposal and performed a competitive impact analysis. The Board is authorized under 54.1-2400 to “*promulgate regulations in accordance with the Administrative Process Act (§ 9-6.14:1 et seq.) which are reasonable and necessary to administer effectively the regulatory system.*” There is no restraint on competition as a result of promulgating this regulation.

Given that the Board has a statutory mandate to promulgate a regulation for CE credit for volunteer hours, it selected the alternative that would achieve the essential purpose of

encouraging volunteering while not substantially reducing the amount of continuing education necessary to improve and maintain competency.

If a licensee volunteers with the clinics run by the Virginia Dental Association or a similar clinic, he or she would be able to satisfy two of the 15 hours of continuing education required for renewal.</i></p> <p>Subsections are added to allow a licensee to request an extension for CE of up to one year upon written request with an explanation prior to the renewal date.</p> <p><i>Currently, the statute allows the Board to grant extensions or exceptions, but regulations have not so authorized. The addition of the extension language will benefit licensees who have difficulty completing CE by the renewal deadline, but it does not relieve them of the requirement to obtain the required hours.</i></p>
