Ms. Roukous reported that the Committee found that Dr. Mayberry failed to submit a transcript, certification or documentation of training content from a Commission on Dental Accreditation of the American Dental Association (CODA) accredited dental program to confirm that he completed training which meets the educational and training qualifications according to guidelines published by the American Dental Association (Guidelines for Teaching the Comprehensive Control of Anxiety and Pain in Dentistry) in effect at the time the training occurred.

The Committee further found that Dr. Mayberry did not meet the qualifications for a permit to Administer Conscious/Moderate Sedation by any method of administration; therefore, the Committee denied Dr. Mayberry’s Application for a Permit to Administer Conscious/Moderate Sedation by any method of administration.
