INFORMAL CONFERENCE

Paul Graham Bodie, M.D.

Dr. Bodie appeared before the Committee to respond to its inquiry regarding the possible refusal to issue a license to practice medicine pursuant to Virginia Code 54.1-2915(A)(4).

Upon conclusion of the open session with Dr. Bodie, Dr. Lee moved to convene a closed session pursuant to section 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Dr. Bodie.. Additionally, she moved that William Harp, MD, Alan Heaberlin and LaTonya D. Hucks attend the closed meeting as their presence would aid the Committee in its deliberations. The motion was seconded and carried.

Upon motion made, seconded and carried, the Committee returned to open session following the procedure for certification of an executive meeting pursuant to Virginia Code Section 2.2-3712.

Dr. Bodie requested the Board's permission to withdraw his application for licensure.
