The Board of Health has adopted these regulations to implement § 23-35.9 through 23-35.13 and is authorized to make, adopt, promulgate, and enforce these regulations by § 32.1-122.6:02. § 23-35.9 and 32.1-122.6:01 authorize the Board of Health to award annual scholarships to full-time graduate students enrolled in a nurse practitioner program or a nurse midwife program in the Commonwealth of Virginia.

The State Health Commissioner, an executive officer of the Board of Health, does not see a viable alternative for achieving the purpose of the existing regulation.

VDH did not receive any public comments pertaining to the regulations during the periodic review period. An informal advisory group was not formed for the purposes of assisting in the periodic review.

Effectiveness

There are five (5) \$5,000 scholarships awarded per fiscal year. For every annual scholarship that is awarded, practitioners must provide medical care in a Virginia Medically Underserved Area (VMUA) for one year. This program has impacted public health by increasing the number of qualified nurse practitioners/nurse midwives practicing in medically underserved areas in the Commonwealth of Virginia.

Result

VDH recommends that the regulations should be retained. Amendments are not recommended at this time.

This regulation is necessary in order to increase access to quality primary care for Virginia residents in medically underserved areas. Public comments were not received regarding this regulation. The regulation is very straight forward and does not overlap or duplicate other regulations. This regulation was last evaluated in 2009. This regulation is not burdensome to small businesses, and, in fact, may be of benefit to the establishment of clinical practices (many of which are small businesses) in Virginia.

Family impact

In general, this regulation has a positive influence on the institution of family and family stability. The medical scholarships assist nursing students with their educational expenses and enable students to save disposable family income and increase their future earnings. Increasing access to primary care in medically underserved areas promotes the health and well-being of families in these communities.
