Section 3.2-4302 of the Code of Virginia authorizes and empowers the Director of the Division of Marketing of the Department of Agriculture and Consumer Services, with approval of the Commissioner of Agriculture and Consumer Services, to establish and promulgate grades for agricultural products that will indicate quality, condition, and other characteristics and to prescribe and promulgate rules and regulations governing the voluntary use of such grades.

Alternatives

Please describe all viable alternatives for achieving the purpose of the existing regulation that have been considered as part of the periodic review process. There is no viable alternative to 2 VAC 5-290. This regulation establishes grade standards for breeder sheep. There are no other known universal standards for breeder sheep; therefore there would be no impartial way to evaluate the quality of breeding stock without this regulation. The standards established

in this regulation are applied as requested by the industry. This regulation reflects the least burdensome alternative available for achieving the purpose of the regulation.

Effectiveness

This regulation is necessary for the protection of the economic welfare of the Commonwealth's breeder sheep industry because it provides a means to evaluate the quality of breeding stock. The breeder sheep industry is a significant economic sector in Virginia. In order to produce slaughter animals of high quality and to maintain breeding flocks of suitable characteristics, a means to evaluate the quality of breeding stock is essential. The regulation provides the needed criteria to use in making accurate evaluations of breeding stock regarding their suitability for breeding purposes and the desirability of their offspring. The regulation is clearly written and easily understandable by the individuals and entities affected.

Result

The agency is recommending that the regulation stay in effect without change. There are no standards for breeder sheep; therefore, this regulation provides the only means to evaluate breeder sheep quality.

The agency has determined that there is a continued need for this regulation in order to provide a fair and equitable grading standard for evaluation of breeder sheep. Many farms that have breeder sheep are small businesses, and this regulation assists these entities in evaluating their stock to determine quality. This regulation does not overlap, duplicate, or conflict with federal or state law or regulation. The regulation was last evaluated by periodic review in 2011. In the period since this regulation was last evaluated, there have been no significant changes in technology, economic conditions, or other factors. The standards established in this regulation are applied on a voluntary basis and do not create a burden to small businesses.
