# Legal basis

Section 3.2-3204 of the Code of Virginia authorizes the Milk Commission to adopt regulations necessary to carry out the purpose of the Milk Commission, which includes the supervision of the producer price, supply, and the sale of fluid milk in Virginia.

This regulation provides for the supervision, regulation, and control of the production, processing, transportation, storage, distribution, and sale of milk and cream in the Commonwealth. As the regulation contributes to the viability of the dairy industry in the state, the agency believes the present version is the

least burdensome and least intrusive to the citizens and businesses of the Commonwealth. There are no viable alternatives to achieving the purpose of the existing regulation.

This regulation is necessary for the protection of public health, safety, and welfare in that it ensures that Virginians will have an adequate supply of milk and that dairy farmers receive a fair price for their milk. The regulation is clearly written and easily understandable.

#### Result

The agency recommends that the regulation stay in effect without change because it is necessary to adequately maintain a stable milk market and is effective in its current format. No changes to agency or industry practices have occurred that would necessitate any modifications to this regulation.

The agency has determined that there is a continuing need for this regulation in order to support the Virginia dairy industry. The climate in Virginia and other regions of the Southeastern U.S. is not

considered ideal for dairy production. These State Milk Commission regulations provide some incentive for dairy farmers, many of whom are small business owners, to continue operations within the Commonwealth because the regulations allow for farms that own milk quota to be paid an amount greater than the price established by the federal government.

There have been no complaints from the public concerning the regulation. The regulation is not unnecessarily complex. There is no overlap with the federal or state law or regulations. The agency has determined that no changes have occurred in the area affected by this regulation since the last periodic review that would make it necessary to amend or repeal the regulation. The agency has determined that the current version of the regulation is consistent with current industry practices and is the least burdensome and least intrusive alternative.
