## Legal basis

Section 3.2-109 of the Code of Virginia (Code) establishes the Board of Agriculture and Consumer Services (Board) as a policy board and authorizes the Board to adopt regulations in accordance with the provisions of Title 3.2 of the Code. Section 3.2-703 of the Code authorizes the Board to quarantine the Commonwealth or any portion thereof when it determines that such action is necessary to prevent or retard the spread of a pest into, within, or from the Commonwealth.

## Alternatives

Include an explanation of why such alternatives were rejected and why this regulation is the least burdensome alternative available for achieving the purpose of the regulation.

This regulation was created in 2003 to establish a quarantine to limit the movement of articles that present the risk of spread of the pine shoot beetle (PSB) after the PSB was first detected in a Christmas tree planting in Clarke County, Virginia. The quarantine was expanded to include Loudoun County in

2010 after a PSB was found in a trap in that county. No additional PSBs have been detected in Virginia since 2010. The quarantine prohibits the movement of the following pine products from the regulated area: bark nuggets (including bark chips); Christmas trees; logs with bark attached; lumber with bark attached; nursery stock; raw pine materials for wreaths and garlands; and stumps as well as any article, product, or means of conveyance which, in the determination of the Commissioner of the Department of Agriculture and Consumer Services, presents the risk of spread of the PSB. The agency determined that these requirements are not unnecessarily burdensome and provide an important means to prevent the artificial spread of this pine pest. Therefore, alternatives to this regulation were rejected.

This regulation is necessary for the protection of public health, safety, and welfare because it prevents the artificial spread of PSBs and is clearly written and easily understandable.

the regulation as is, consistent with the stated objectives of applicable law, to minimize the economic impact of regulations on small businesses.

The purpose of this regulation is to delay the long distance (artificial) spread of the PSB from infested areas to non-infested areas in order to reduce its impact on Virginia landowners, including Christmas tree growers, many of whom are small business owners, and forest users The agency has determined that this regulation should be retained in order to provide protection against the artificial spread of the PSB.

There have been no complaints from the public concerning the regulation. This regulation does not overlap, duplicate, or conflict with federal or state law or regulations. The agency has determined that no changes have occurred in the area affected by this regulation since the last periodic review that would make it necessary to amend or repeal the regulation. The agency has determined that that current version of this regulation is consistent with current industry practices and is the least burdensome and least intrusive alternative.
