The promulgating agency is the Common Interest Community Board ("the Board").

Section 54.1-2349(A) of the Code of Virginia gives the Board the power and duty to establish criteria for the licensure of common interest community managers and certification of employees of common interest community managers who have principal responsibility for management services provided to a common interest community or supervisory responsibility for employees who participate directly in the provision of management services. The regulation also tasks the Board with approving criteria for accredited common interest community manager training programs and promulgating regulations establishing standards of conduct for common interest community managers and for certificated employees of common interest community managers.

Code of Virginia § 54.1-201(A)(1) gives the Board the power and duty to "establish the qualifications of applicants for certification or licensure by any such board, provided that all qualifications shall be necessary to ensure either competence or integrity to engage in such profession or occupation."

Code of Virginia § 54.1-201(A)(5) gives authority to the Board to promulgate regulations. It states, in part, that the Board has the power and duty "[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) necessary to assure continued competency, to prevent deceptive or misleading practices by practitioners and to effectively administer the regulatory system administered by the regulatory board."

Alternatives to Regulation

No alternatives were considered as part of this periodic review. The regulation enables the Board to fulfill the statutory requirements established in Chapters 2 and 23.3 of Title 54.1 of the Code of Virginia. Further, the regulation is necessary to ensure that the Board's statutory requirements are executed in the least burdensome and most efficient and cost-effective manner possible while protecting the citizens of Virginia.

Effectiveness

The regulation meets the criteria set forth in the Office of Regulatory Management procedures. The regulation contains the requirements for obtaining licensure as a common interest community manager,

certification as a certified principal or supervisory employee, and approval as a common interest community manager training program. The regulation also establishes methods for renewal of licenses and certificates and standards of practice and conduct to ensure competence and integrity of all regulants and to administer the regulatory program in accordance with Chapters 2 and 23.3 of Title 54.1 of the Code of Virginia. The regulation is necessary for the protection of the public and is clearly written and understandable.

Decision

On September 21, 2023, the Board voted to retain the regulation "as is" without any change, as explained further in the "Small Business Impact" section. In accordance with the Governor's Executive Directive Number One (2022), the Board is currently undertaking a separate action to perform a comprehensive line-by-line review of this regulation.

Small Business Impact

Code of Virginia §§ 54.1-201(A)(1), 54.1-201(A)(5), and 54.1-2349(A) mandate the Board promulgate regulations. The continued need for the regulation is established in statute. Repeal of the regulation would remove the current public protections provided by the regulation. The Board provides protection to the safety and welfare of the citizens of the Commonwealth by ensuring that (i) only those firms that meet specific criteria set forth in the statutes and regulations are eligible for licensure as a common interest community manager, (ii) only those individuals that meet specific criteria set forth in the statutes and regulations are eligible for certification as a certified principal or supervisory employee, and (iii) only those common interest community manager training programs meeting the requirements of statute and regulations are approved by the Board.

There were no comments or complaints received during the public comment period. The Common Interest Community Manager Regulations are clearly written, easily understandable, and do not overlap, duplicate or conflict with federal or state law or regulation.

The most recent periodic review of the regulation occurred in 2019. Currently, the Board is conducting a comprehensive review of the regulation.
