Call to Order

The Board recessed for lunch at 12:00 noon and reconvened at 12:30 p.m.

Lunch

Ms. Ware opened the floor for nominations of Chairman and Vice Chairman. A motion was made by Mr. Ruais to nominate Mr. Rubinstein as Chairman. A motion was made by Ms. Harmon to nominate Mr. Schuyler as Chairman. A motion was made by Ms. Harmon and seconded by Ms. Clare to close nominations for Chairman. A vote was held for Chairman by the show of hands. Members voting "Yes" for Mr. Rubinstein were Maples, Ruais, Adkins, Dupuy, Rubinstein, and Clare. Members voting "Yes" for Mr. Schuyler were Bhatt, Harmon, and Schuyler. Mr. Rubinstein was elected Chairman by majority vote. Mr. Scott did not participate in the vote because he was not a sworn member.

Election of Chairman and Vice Chairman

A motion was made by Ms. Dupuy to nominate Ms. Harmon as Vice Chairman. A motion was made by Ms. Clare and seconded by Mr. Maples to nominate Mr. Schuyler as Vice Chairman. A vote was held for Vice Chairman by the show of hands. Members voting "Yes" for Mr. Schuyler were Rubinstein, Maples, Ruais, Adkins, Clare, Bhatt, and Schuyler. Members voting "Yes" for Ms. Harmon were Dupuy and Harmon. The motion nominating Mr. Schuyler as Vice Chairman passed by majority vote. Mr. Schuyler was elected Vice Chairman. Mr. Scott did not participate in the vote because he was not a sworn member.

An Education Committee which consists of Mr. Maples, Mr. Ruais, and Ms. Clare was selected. A motion was made by Mr. Harmon and seconded by Ms. Dupuy to nominate Ms. Clare as Chairperson of the Education Committee. The motion passed unanimously. Members voting "Yes" were Rubinstein, Maples, Ruais, Adkins, Dupuy, Clare, Harmon, Bhatt, and Schuyler. Mr. Scott did not participate in the vote because he was not sworn in.

Fair Housing Regulations were distributed to the Board members.


Distribution of Regulations
