Case No.: 135185** Dr. Shan appeared with counsel, Kenneth T. Roeber, to discuss the allegations set forth in a Notice of the Board dated June 9, 2011. The Committee received statements from Dr. Shan and Mr. Roeber and discussed the allegations with them.

**DECISION:**

Ms. Ross reported that the Committee found that in providing treatment to Patient A, Dr. Shan failed to completely fill and obturate the canals of tooth #3; delivered an ill-fitting crown with open margins on tooth #3; provided "hard composites" on tooth #2, despite the fact that she was unable to remove all decay; failed to use a rubber dam during root canal treatment; and failed to use a lead apron when taking digital radiographs.

Ms. Ross further reported that the Committee found that Dr. Shan failed to maintain complete and accurate treatment records for Patient A.

The sanctions reported by Ms. Ross were that Dr. Shan shall complete 7 hours of continuing education in recordkeeping and risk management; 4 hours of continuing education in endodontics; and 4 hours of continuing education in restorative dentistry. Dr. Shan was assessed a \$2,500 monetary penalty.

Ms. Howard moved to adopt the decision of the Committee. The motion was seconded and passed.

**Approval of Minutes:**

Upon a motion by Ms. Howard, the minutes from the Informal Conferences conducted on May 7, 2010; December 2, 2010; June 10, 2011; and July 15, 2011 were approved.
