MARINA E. QUINTANILLA

A formal hearing was held in the matter of Marina E. Quintanilla to discuss allegations that she may have violated certain laws and regulations governing the practice of pharmacy technicians in Virginia.

James E. Schliessmann, Assistant Attorney General, prosecuted the case with the assistance of Mykl D. Egan, DHP Adjudication Specialist.

Scott A. Arnott, DHP Senior Investigator and Robert Kailer, Asset Protection Investigator, testified on behalf of the Commonwealth.

Ms. Quintanilla testified on her own behalf.

Closed Meeting: Upon a motion by Mr. Ross and duly seconded by Mr. Brown, the Panel voted 7-0, to convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the

purpose to reach a decision in the matter of Marina E. Quintanilla. Additionally, he moved that Scotti Russell, and Howard Casway attend the closed meeting.

Reconvene:

JAMES Q. UNDERWOOD, III  
Pharmacist Reinstatement

A formal hearing was held in the matter of James Q. Underwood, III, following his request for a formal hearing to discuss his petition for reinstatement. Mr. Underwood's license was summarily suspended pursuant to a Board Order entered on March 28, 2008, and his reinstatement request was denied pursuant to a Board Order entered on June 9, 2008.

James Schliessmann, Assistant Attorney General, prosecuted the case with the assistance of Mykl D. Egan, DHP Adjudication Specialist.

Vicky Fox, DHP Senior Investigator, testified on behalf of the Commonwealth.

Mr. Underwood testified on his own behalf.
