Greg stated the support and love that everyone expressed meant a lot to him, Bobby's family and friends.</p>

Chair Report – Dr. Allen Yee:	Dr. Yee thanked the committee members that worked on Project Remley and it seems to be going well. It will be presented a little later on the agenda. This is the first phase of the project and there's more to come.	
OEMS Report – Tim Perkins/OEMS Staff/Other:	Tim explained where to go in the event attendees need to make or receive a phone call; either outside the back door or front door areas so as not to disrupt the OEMS staff. 	<p>Michael Berg gave an update on the regulations. The DDNR Regulations 12VAC566 have resided in the governor's office for 252 days. The EMS Regulations 12VAC531, which have been approved by the Commissioner, have been residing in the Secretary of Health and Human Services Office for the past 56 days. Met with the legislative liaison for VDH last week and was advised that all regulatory activity is halted to address all the General Assembly activity and the redistricting issues. The Northern Virginia Program Representative position has been filled by Adam Harrell of Halifax and he will start May 25.</p> <p>Gary stated that the Annual Fallen Firefighters Memorial Service is being held Saturday, June 4 at the Richmond International Raceway. He also mentioned that the Obama administration is planning to establish a Federal EMS Office and he has attended a couple of webinars concerning this and NASEMSO has conducted a survey on this matter. It will be located under the Department of Health & Human Services. More information to follow.</p> <p>The Atlantic EMS Council will no longer administer testing. OEMS will be using National Registry for testing beginning January 1, 2013. Please see the OEMS Quarterly Report on the website for this and other current updates.</p> <p>Board of Health Update – Bruce Edwards The State Trauma Triage Plan was finally approved. One of the agenda items at the Board of Health meeting was the legislation for VDH to regulate abortion clinics in becoming licensed facilities.</p>	
<p>Project Remley Update – Dr. Allen Yee:</p>	 <p>Project remley.physicians.ppt</p> <p><u>Physicians Guide to Helicopter EMS Use in Virginia</u> The team did not address fixed wing air medical transport, this is strictly rotary wing. The helicopter dispatch center pages were edited during the meeting. On the Utilization page, it was agreed to list the position paper websites for utilization/allocation. The team also discussed showing 30-35 minute flight time map to show that the entire state is covered; the length of time is just a bit longer. It was also suggested to list the Regional Councils. Tim will include the links to the State EMS Plan and the Medevac Resource Document also. Tim will make the suggested changes and send to the committee members before sending it to the Commissioner.</p> <p>On the next phase of the project we have an opportunity to recommend changes to the system. What would it take to sustain our systems? This is one of Dr. Remley's questions. The health care climate is changing rapidly. Is a 30-40 minute response time acceptable in those three areas that are not covered? The committee discussed the state coverage and decided to do another map which shows 30 or 35 minute rings. Dr. Yee suggested highlighting the uncovered areas without the rings. It was also suggested to do the map by zip code and color code the times in 15 minute increments.</p> <p>One of the other things that Dr. Remley wants to address is safety. It was suggested that Anita and Susan submit what they have been doing along with the obstacles that they faced and overcame or are continuing to see. Susan will send Tim a copy of the patient follow up template. This is for all patients not just trauma patients.</p>	<p>Susan will send Tim the template of the flight crew patient follow up.</p>
<p>Virginia WeatherShare Program Development Update/Safety Work Group Update – Paul Davenport:</p>	<p>Paul has no update at this time. He reported that the WeatherShare LZ directory testing went fine and there were no server crashes or anything. He will put together a presentation to be sent out to the committee. VHHA has funded a lot of this work and the LZ directory has become a part of the WebEOC facility. All of the hospitals in Virginia have entered their LZ directory information. As an incentive and requirement to keep their information current, they will receive federal disaster funding. This site will also include pictures. <p>Project Synergy Work Group Update – Susan Smith/Anita Ashby:</p>	<p>Susan and Anita continue to do local presentations. They will also teach at the 2011 OEMS Symposium in November. Last year they presented to about 70 people from 15 different agencies. This is a good avenue to reach more people. They also presented at the last Trauma System Oversight & Management Committee meeting on March 3 and it went very well. The TSO&MC were very supportive.</p>

Will have full NVG capability by the middle or end of June.</p> <p>Mark Smith, Fairfax Co. Police – They have a new 429 and should take delivery the end of August. The second one will be delivered in December. One of the 407’s has been sold to a Medevac company in California. Hired a new Pilot and a new Director of Maintenance.</p> <p>Paul Davenport, Carilion Clinic LifeGuard – There is a weekend concert series across from the hospital called “Down by the River”. The 25th Ground Anniversary and 30th Air Anniversary will be celebrated there in conjunction with the concert and other events on Saturday, May 14 from 3:30 p.m. to 6:30 p.m. June 4th is the 7th Annual StarPoints Symposium with lots of presentations.</p> <p>R. N. Possumato, VSP – As of the end of last week, we took possession of our second new EC145. They will be the primary EMS aircrafts for MFI and II. The medical crews are doing their configuration training.
