A telephone conference call meeting of the Virginia Board of Nursing was held August 25, 2009 at 8:30 A.M. William Clay Garrett, Assistant Attorney General, presented evidence that the continued nursing practice of James Wright, C.N.A. 1401-057072 may present a substantial danger to the health and safety of the public.

Ms. Hale moved to summarily suspend the nurse aide certificate of James Wright pending a formal administrative hearing and to offer a consent order for revocation of his certificate with a finding of abuse, in lieu of a formal hearing. The motion was seconded and carried unanimously.
