 Provide a completed preceptor packet to include the performance of skills for which the student has had faculty supervised clinical and didactic preparation [18VAC90-20-95.D.3.];

In addition, a Board representative will conduct a site visit to verify compliance with the mental health clinical experiences [18VAC90-20-120.B.].

Additionally, quarterly reports will be submitted while on conditional approval. The first quarterly report is due by April 2, 2012.

Star College – Practical Nursing Education Program, Falls Church

Roni Lake, RN, Program Director and Fred Amematsro, RN were in attendance.

At 9:50 p.m., Ms. Jones-Clarke moved that the Education Informal Conference Committee convene a closed meeting pursuant to §2.2-3711 (A) (28) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Star College Practical Nursing Education Program in Falls Church. Additionally, she moved that Dr. Saxby, Ms. Dowling and Ms. Mueller attend the closed meeting because their presence in the closed meeting was deemed necessary.

The motion was seconded and carried unanimously. The Committee reconvened in open session at 10:00 p.m.

Ms. Jones-Clarke moved that the Education Informal Conference Committee heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened.

Action: Recommend placing the program on conditional approval and withdraw approval to admit students until the time the Board can verify compliance of the violations of the Board of Nursing regulations as cited in the survey visit report of October 12-13, 2011 listed below:

- 1. Unable to verify clinical agencies utilized for clinical instruction are in good standing with their licensing bodies. The clinical agency form does not include this information for some agencies and the last survey date for others has dates such as 1977, 1991, etc [18VAC90-20-70.B.] [18VAC90-20-130.G.];
- 2. Unable to verify faculty formulating and accepting the program's philosophy and objectives. No written evidence of faculty involvement within the faculty job description, systematic evaluation plan, or meeting minutes [18VAC90-20-80.1];

- Unable to verify that faculty meets licensure requirements of the jurisdiction in which the practice occurs. Many of the clinical sites utilized by the program are located in Maryland and Washington D.C. Three faculty members do not hold licenses in Washington D.C. The program director did not provide a list of faculty and the clinical sites that they provide instruction as requested during the visit [18VAC90-20-90.A.2.];
- Unable to verify professional competence of program director and faculty through various professional activities and/or practice. No resumes were provided to verify nursing practice experience as it relates to course assignments for faculty [18VAC90-20-90.A.3];
- 5. Unable to verify a sufficient number of faculty to prepare the students to achieve the objectives of the program. There are no full time faculty, according to the program director. The program director is the director and owner of Star College and Knowledge First in Maryland. In addition to Ms. Lake's responsibilities as owner of two healthcare education schools, she teaches courses at Montgomery College for nurse aide and medication tech programs. As a result of the lack of faculty and a program director whose focus is solely the PN program, at risk students are not able to receive additional remediation and tutoring [18VAC90-20-90.B.1.];
- 6. Unable to verify faculty developing, implementing, and evaluating the philosophy and objectives of the nursing education program; developing and evaluating student admission, progression, retention, and graduation policies within the framework of the controlling institution; providing opportunities for student and graduate evaluation of the curriculum, teaching, and program effectiveness; and documenting actions taken during faculty and committee meetings. No written evidence of faculty involvement within the faculty job description [18VAC90-20-90.C.1,3,5,6];
- 7. Unable to verify the use of preceptorship experience as directed by Board regulation. The program director stated that the program does not utilize preceptors or have a preceptorship clinical component. Students state that they are paired with a staff nurse preceptor during their leadership clinical [18VAC90-20-95];
- 8. Unable to verify program admission requiring a high school diploma/GED certificate/college credit. The student handbook (p.15) states that each applicant is required to have a high school diploma *or* equivalent *or* take and pass a standardized entrance exam given by Star College (need at least 60% to pass). Ms. Lake and Mr. Okigbo stated that students have been admitted to the program without evidence of high school completion of two or more years; GED certificate; or college credit but with a passing entrance exam only [18VAC90-20-100.B.];
- 9. Unable to verify a system of records being maintained by the program, i.e. minutes of faculty and committee meetings. The program has meeting minutes for two faculty meetings dated on September 29, 2011 and October 11, 2011. Ms. Lake stated that the date of the meeting minutes was an error; it should be dated September 28, 2010. Ms. Lake, also, stated that she held many informal faculty meetings but did not document what was discussed;

- no informal meeting dates were provided to the Board representative [18VAC90-20-110.A.3.];
- 10. Unable to verify student files being maintained as required by Board regulation. Of the eight (8) random current student files reviewed, zero (0) files included an application or a signed exit comprehensive exam policy. Of the eleven (11) random graduate files reviewed, seven (7) files included an application; five (5) files included a high school transcript or equivalent; eight (8) files included achievement records; one (1) included a final transcript [18VAC90-20-110.B.];
- 11. Unable to verify that current information about: graduation requirement; fees; expenses; faculty-staff roster; school calendar; and annual passage rates on the NLCEX exam are published and distributed to students, applicants for admission, and the Board. The exit comprehensive exam is not stated as a graduation requirement for the program. The exit comprehensive exam policy does not mention consequences of failure or remediation requirements. There is a graduation fee (\$100) but administrators did not provide an explanation for this fee. The grading scale is inconsistent. In some documents (syllabi and handbook) it is listed that 75%, 80% and 78% are considered a passing grade. The students pay an additional expense for a clinical bag (\$75) but they do not receive a clinical bag. The administrators did not provide an explanation for charging students for a clinical bag without supplying one to each student [18VAC90-20-110.C.3-5,12-14];
- 12. Unable to verify supervised clinical experience across the lifespan and in a variety of settings. The evening students stated that they did not obtain direct hands-on maternity clinical experience; but were offered pediatric clinical hours at ACCA Child Development Center instead. The Mental Health Nursing course syllabi have course objectives related to pediatric care. Program director resubmitted copies of all course syllabi stating that the revised versions had the correct information but the information was the same [18VAC90-20-120.B.1]:
- 13. Unable to verify the following within the curriculum: conflict resolution; patient rights; nutrition and diet therapy; and bioterrorism [18VAC90-20-120.B.4b;5b;6;7d];
- 14. Unable to verify instruction in child abuse recognition and intervention [18VAC90-20-120.D.];
- 15. Unable to verify a minimum of 400 direct care supervised clinical hours within the curriculum. The number of clinical hours on the syllabi, curriculum outline, and handbook are not consistent. Healthy Babies Inc. located in Washington D.C. is listed as a maternity clinical site but the evening students are not able to utilize the site due to program hours and clinical agency site hours conflicting. ACCA Child Development Center representative stated that students did not have a focus or objectives to accomplish during their time at the clinical site. Program director stated that simulation is utilized but only for skills acquisition not in lieu of clinical experience. Faculty meeting minutes dated September 28, 2011states that simulation is assigned for the Pediatric course (last page) but there is no pediatric simulation equipment [18VAC90-20-120.E.];
- 16. Unable to verify periodic evaluation of the program. A summary of course evaluations was provided to the Board representative. This

- summary did not include dates or the name of the instructor. No graduate or employer surveys were provided. Unable to verify that the Systematic Evaluation Plan is implemented due to a lack of faculty meeting minutes to reflect the criteria being evaluated [18VAC90-20-130.A]:
- 17. Unable to verify that the facility meets the objectives of the program. The skills lab does not have sufficient supplies and equipment to meet the objectives of the program. The facility does not have adequate office space and furniture for faculty and program director [18VAC90-20-130.C];
- 18. Unable to verify learning resources that are current and sufficient to meet the needs of the students and faculty. The majority of books located in the locked cabinet for students are older than five years, dates range from 1997-2007. Required textbooks have dates ranging from 2003-2006 [18VAC90-20-130.D].

In addition, the Board may conduct a site visit at the Board's discretion to verify compliance.

Additionally, continue quarterly reports while on conditional approval. The next quarterly report is due by April 2, 2012.

Action: Recommend granting full approval to this pre-licensure ADN nursing education program. The next scheduled survey visit will in 2017.

Initial Approval Survey Visit

University of Virginia's College at Wise – Baccalaureate Degree Nursing Education Program, Wise

Action: Recommend granting full approval pending the receipt of the following requirement within thirty (30) days:

Evidence of the issuance of new contract for Wellmont Health System correcting the typo of omission and writing an addendum to the Southwest Virginia Mental Health Contract identifying that a faculty would be responsible [18VAC90-20-130.E.1.and 2.].

Continued Approval Survey Visit

Chesterfield County Public Schools – Practical Nursing Education Program, Chesterfield

Action: Recommend to grant continued approval pending receipt of the following requirements within thirty (30) days:

- 1. Provide in the Program Director's position description the authority to hire and evaluate faculty, and to recommend and administer the program budget consistent with established policies of the controlling agency [18VAC90.20.70.C. 3,4.];
- 2. Provide in the Faculty's position description the authority to perform the functions as stated in the regulation. The items were verified verbally by the faculty that they have the authority but are not written in the position description [18VAC90-20-90.C.1-6];
- 3. Provide evidence that content containing the prevention of patient abuse, neglect and abandonment are included in the curriculum. In Psychiatric Nursing, (Nursing Care of Selected Populations of Patients), Objectives 8-12 identify the terms abuse and victim, but do not state any content objectives for prevention of abuse, neglect and abandonment [18VAC90-20-120.5.c.];
- 4. Provide documentation that the program has learning resources that are current, pertinent and accessible to students and faculty, and sufficient to meet the needs of the students and faculty. AV materials had dates of 1996, 1991, 1994 etc. as well as reference books of 2001, 2003 [18VAC90-20-130.D.]; and
- 5. Develop a plan to provide secretarial support to meet the needs of the Program Director and faculty [18VAC 90-20-130.B.]. (This requirement was cited in the last Survey Report of March, 2003).

Continued Approval Survey Visit

New River Community College – Associate Degree Nursing Education Program, Dublin

Action: Recommend continued full approval pending receipt of the following requirements within thirty (30) days:
