ESTABLISHMENT OF A QUORUM

With eight (8) members of the Board present, a quorum was established.

CALL TO ORDER AND INTRODUCTIONS

Chairman Street called the meeting to order at 10:00 a.m. and called for introductions.

Mr. Gooch announced that this would be his last meeting with the Soil and Water Conservation Board as he was leaving the Office of the Attorney General.

Director Cristman thanked Mr. Gooch for his seven years of service to the Board and the agency.

APPROVAL OF MINUTES FROM MARCH 20, 2019

BOARD ACTION

Mr. Wilson moved that the minutes from the March 20, 2019 meeting of the Virginia Soil and Water Conservation Board be approved as submitted. Mr. Arnason seconded and the motion carried.

Mr. Coyner observed that the section regarding the Equine Workgroup should be more comprehensive and not just limited to horse pasture management.

BOARD ACTION

Mr. Marten moved that the minutes from the March 20, 2019 meeting of the Virginia Soil and Water Conservation Board be amended to address concerns regarding the Equine Workgroup and staff was directed to make the necessary edits to the document. Mr. Coyner seconded and the motion carried.

<u>DIRECTOR'S REPORT</u> – Clyde Cristman, DCR Director

Director Cristman noted the following in his report.

- He thanked Ms. Howard-Cooper for serving the role of Acting Director of the Division of Dam Safety and Floodplain Management. The agency will be posting an announcement to recruit for a permanent Director position within the next week.
- Wayne Davis, former Eastern Area Regional Manager, has retired.
- Governor Northam's office announced the submission of the draft Chesapeake Bay TMDL Phase III WIP (Watershed Improvement Plan). Mr. Baxter and Mr. Glover met with the EPA earlier in the week to review the plan.

DAM SAFETY AND FLOODPLAIN MANAGEMENT – Wendy Howard-Cooper, Acting Director, Division of Dam Safety and Floodplain Management

Ms. Howard Cooper noted that the majority of the Dam Safety and Floodplain Management issues would be addressed at the May meeting.

DCR staff met with officials from the City of Lynchburg on April 12 to discuss moving forward with the \$5 million appropriation for the repair of College Lake Dam. DCR staff are in the process of working with

the City to develop a grant agreement for this appropriation. The City is currently preparing a scope of work. A motion allocating the funds on July 1, 2019 will be presented to the Board at the May meeting.

Director Cristman noted that the General Assembly appropriated \$5 million specifically for this dam. The City intends to decommission the dam, although there is a road across the dam which makes the decommissioning more challenging.

Ms. Howard-Cooper reported that the pilot project approved by the Board at the March meeting is moving forward. DCR has signed a letter of intent with the Army Corps of Engineers. Meetings have been scheduled with the City of Franklin and Southampton County. A meeting will be scheduled with respective dam owners.

Dam Safety, Flood Prevention and Protection Assistance Fund Grant Round Update

Ms. Howard-Cooper reported that fifty-two (52) grant applications had been received on time. Two additional applications had been received after the deadline and were disqualified. Nine of the fifty-two were incomplete. Those applicants were given the opportunity to submit the required information.

There is \$1 million available for grant funding. That includes up to \$400K for flood prevention and \$600,000 for dam safety. Applications were received for \$390K of the available flood prevention funding, and \$828K of the dam safety funding. If all projects are eligible, applications will have to be denied for the first time through this grant process. Applications will be scored according to the grant manual criteria. All of the available funds will be awarded. High hazard dams will be prioritized.

Ms. Howard-Cooper advised that the General Assembly had appropriated \$400K for the agency to fund remote monitoring for district owned dams. The agency is currently meeting with vendors who provide this type of equipment. Director Cristman noted that the Jordan Dam on the Maury River is scheduled to be decommissioned. That is likely to happen in May.

SOIL AND WATER CONSERVATION DIVISION REPORT

Division Report – Darryl Glover, Director, Division of Soil and Water Conservation

Mr. Glover gave the following written report:

Mr. Chairman, members of the Virginia Soil and Water Conservation Board, please accept this Soil and Water Conservation Division Report.

Chesapeake Bay WIP III

The "Draft Chesapeake Bay TMDL Phase III Watershed Implementation Plan" (WIP III) was released to the public on April 5. Public comments will be accepted through June 7, with a final WIP completed in early August. Comments can be submitted via:

DEQ evaluated the agricultural BMP input decks (i.e. projections of numbers of each type of BMP that could be implemented by year 2025) of the 31 (minus the 32nd District, Southside, which was exempted due to a heavily forested Bay watershed area) Soil and Water Conservation Districts in Virginia with Chesapeake Bay drainage. This evaluation concluded that if fully implemented, 73% of the total combined reductions for nitrogen and phosphorus for all 31 of these Districts would be achieved by these ten Bay Districts: Eastern Shore, Culpeper, Hanover-Caroline, Headwaters, Lord Fairfax, Northern Neck, Robert E. Lee, Shenandoah Valley, Three Rivers, and Thomas Jefferson. Both the U.S. Environmental Protection Agency and the U.S.D.A. Natural Resources Conservation Service have been notified that the Commonwealth supports additional financial assistance in these areas. Accordingly, we shall propose measures to recognize these Districts' level of commitment to Chesapeake Bay cleanup via recommendations for FY20 Board policies during this meeting.

All agricultural BMP input decks were augmented, at the state level, in order to achieve targeted nutrient reductions. Increases to input decks were most notable for nutrient management (core and enhanced), cover crops, conservation plans (which include DCR plans, NRCS plans, and Resource Management Plans), and poultry litter transport (from 5,000 – 6,000 tons/year to 89,000 – 90,000 tons/year by year 2025). In addition to these agricultural BMPs, WIP III also emphasizes animal waste facilities, grass and forested buffers, and (additional) livestock stream exclusion.

WIP III recognizes the work of the Agricultural BMP Technical Advisory Committee (TAC) during 2018, which will continue through 2019, to propose changes to the Virginia Agricultural BMP Cost Share (VACS) Program that could increase participation and result in additional agricultural BMP implementation. The following TAC recommendations have been incorporated into the FY20 Ag BMP Manual and/or the annual Board policies being submitted for the Board's consideration and approval or will continue to be discussed by the TAC for FY21. These recommendations for the VACS Program noted in WIP III include:

- Create additional incentives for a variety of buffer widths and lifespans;
- Create new incentives for extended BMP lifespans;
- Establish an equine workgroup to address the implementation of BMPs on equine operations including horse pasture and manure management, appropriate stocking rates for horses, conditions for financial assistance, etc.;
- Remove or increase annual participant caps for cost share;
- Bundle BMPs into single cost share contracts to increase reporting of BMPs;
- Increase maximum tax credits for BMPs and conservation equipment;
- Modify practice specifications for cover crops, animal waste and stream protection, forest buffers and nutrient management; and

• Move towards regional agricultural BMP priorities.

<u>Agricultural BMP Technical Advisory Committee</u>

The full Agricultural BMP Technical Advisory Committee (TAC) has scheduled meetings on: July 9, August 14, October 8, November 20, and December 18. Revised ground rules for this year and an updated list of topics for discussion will be distributed to TAC members by the first full week in May.

Livestock Stream Exclusion Update

In order to propose the most efficient allocation of supplemental FY 2019 funding recently awarded by the General Assembly for the remaining PY15 pending SL-6 livestock stream exclusion practices under the 100% cost reimbursement initiative, the Department requested revised cost estimates. The eight affected Soil and Water Conservation Districts (SWCDs) are: Big Walker, Monacan, Mountain Castles, Patrick, Peter Francisco, Pittsylvania, Robert E. Lee, and Southside provided this information in early April. As a result, due to some cancellations, the number of backlogged PY15 SL-6 practices has been reduced, from roughly 100 to approximately 80.

Conservation Planning Certification Training

The RUSLE 2 (soils) training classes, scheduled for the coming months by NRCS, have been updated. The May 8 date has been cancelled. Classes will be on May 15 (Fishersville), June 5 (Richmond NRCS Office), and June 12 (Wytheville). As with the other in-person conservation planning courses, SWCD staff who are enrolled in the curriculum will be notified of the new dates and automatically registered.

Approval of Board's Fiscal Year 2020 Virginia Agricultural Cost-share (VACS) BMP Manual – Christine Watlington, Policy and Regulatory Coordinator

Ms. Watlington advised the Board that copies of changes to the manual were mailed prior to the meeting. She noted that the packet contained the full BMP Manual with the exception of the section on poultry litter transport. That will be brought for approval at the May meeting. She also noted that tables and specifications had been updated.

In addition, Ms. Watlington advised:

- An animal waste variance procedure was added. This was recommended by the subcommittee and approved by the TAC.
- The section regarding carry over practices was revised. Practices that were considered 18 month
 practices are now recommended to be given two-program years to complete installation or
 implementation. The local District can approve a third carryover year. Beyond a third year,
 approval must come from DCR.

BOARD ACTION

Mr. Arnason moved that the Virginia Soil and Water Conservation Board approve the 2020 Virginia Agricultural Cost-Share BMP Manual as presented. Further, the Department is authorized to make nonsubstantive changes to include formatting and stylistic changes as necessary to all approved sections of the Manual. The section of the Manual regarding Poultry Litter Transport is omitted from this approval. Mr. Coyner seconded and the motion carried.

Approval of Whole Farm Approach Pilot Project Grant Agreement and Specification – Christine Watlington

Ms. Watlington advised that this project was presented in March. She also noted that the Board originally approved the allocation for funding at the December, 2018 meeting.

BOARD ACTION

Mr. Coyner moved that the Virginia Soil and Water Conservation Board approve the Department of Conservation and Recreation and Virginia Soil and Water Conservation District Cost-Share and Technical Assistance Grant Agreement for the Implementation of the Whole Farm Approach Pilot Project (Fiscal Year 2019) and the WFA-1 specification. Mr. Wilson seconded and the motion carried.

Approval of Supplemental Grant Agreements for Remaining 2015 SL-6 Practices

This item was deferred until the May meeting.

Review of DRAFT Desktop Guidelines for District Fiscal Operations – Christine Watlington

Ms. Watlington presented the changes to the Desktop Guidelines for District Fiscal Operations. She noted that in future years, the Guidelines may be brought to the Board at the March meeting in order to allow Districts additional time to revise accounting and other procedures for the upcoming program year.

Key changes related to responsibilities in the Administration and Operations grant, changes in the Code of Virginia related to FOIA and others. The Guidelines also clarified the use of gift cards and clarified certain tax forms.

No Board action was necessary at this meeting.

Review of DRAFT Board Policy on Soil and Water Conservation District Administration and Operations Funding Allocations for Fiscal Year 2020 – Christine Watlington

Ms. Watlington presented the Department recommendations to changes based on the expected allocation. Final action will be taken by the Board at the May meeting.

Review of DRAFT Administration and Operations Funding Contract and Deliverables – Christine Watlington

The funding contract and deliverables are based on the Board Policy. Final action will be taken at the May meeting.

Review of DRAFT Board Policy on Soil and Water Conservation District Cost-Share and Technical Assistance Funding Allocations for Fiscal Year 2020 – Christine Watlington

Ms. Watlington reviewed the draft Board Policy. Additional funding for districts heavily impacted by the upcoming WIP efforts was discussed. Final action will be taken at the May meeting.

Review of DRAFT Cost-Share and Technical Assistance Contract and Deliverables – Christine Watlington

The deliverables are based on the contract. Both will be voted on at the May meeting.

Review of DRAFT Grant Agreement for the Virginia Conservation Assistance Program – Christine Watlington

Ms. Watlington reviewed the draft grant agreement for the Virginia Conservation Assistance Program.

- \$1 million is provided from the Water Quality Improvement Fund surplus.
- The agreement is based on the existing grant agreement with the Association and the existing cost-share and technical assistance grant agreements.
- This allows for 80% to go the Chesapeake Bay areas and 20% outside the Bay area.

No Board action was required at this time.

Review of DRAFT Grant Agreement for Resource Management Plan BMP Pilot Project – Christine Watlington

Ms. Watlington reviewed the draft grant agreement with Northern Neck Soil and Water Conservation District for the Resource Management Plan (RMP) BMP Pilot Project. The TAC had recommended that certain practices be bundled into one contract that would make it easier for producers to implement the practices. The hope is to increase the number of RMPs that are certified.

No action was required by the Board at this time.

District Director Appointments and Resignations – Christine Watlington

Ms. Watlington presented the following list of District Director appointments and resignations.

BOARD ACTION

Mr. Newton moved that the Virginia Soil and Water Conservation Board approve the appointments of the individuals being recommended. Mr. Wilson seconded and the motion carried.

Establishment of an Allocation Subcommittee – Christine Watlington

Ms. Watlington noted that in the previous year numerous questions arose concerning how Technical Assistance (TA) is allocated. Currently baseline technical assistance is based on FY 2013 numbers. The staff recommendation is for the Board to establish a subcommittee to review and provided recommendations for alternative ways of funding baseline technical assistance. Membership would include three members of the Soil and Water Conservation Board, three members of the Virginia Association of Soil and Water Conservation Districts, and one staff member from the Department of Conservation and Recreation.

BOARD ACTION

Chairman Street moved the following:

The Virginia Soil and Water Conservation Board establishes an allocation subcommittee to review the current methodology used for calculating the baseline technical assistance allocation to Districts and to provide recommendation(s) for alternative method(s) to determine this baseline.

The subcommittee will consist of 7 members, with 5 members constituting a quorum. Three members shall be active members of the Virginia Soil and Water Conservation Board appointed by the Board Chairman. Three members will be representatives of the Virginia Association of Soil and Water Conservation Districts appointed by the Executive Board of the Association. One member will be the Director of the Department of Conservation and resignation or his designee.

The Subcommittee shall provide its recommendations to the Board no later than the December 11, 2019 Board meeting.

There may be ad-hoc members of the subcommittee, including the Virginia Farm Bureau Federation, but these members will have no voting privileges.

Mr. Newton seconded and the motion carried.

Director Cristman noted that the terms of the three at-large members of the Board would be expiring on June 30. Mr. Street is not eligible to be reappointed. Ms. Kennedy and Mr. Marten have asked not to be considered for reappointment. The Governor's office is working on filling these appointments in a timely manner. Recommendations of individuals to fill these vacancies are welcome and should be forwarded to Director Cristman.

The Association is working on several training programs, including records retention and working with the Library of Virginia.

This summer is the educational season with youth camp and the Envirothon.

PUBLIC COMMENT

Mr. Shreve from the Virginia Agribusiness Council advised that the Council would be sending a number of recommendations to the full TAC regarding the equine workgroup in order to address the equine situation in the context of WIP III.

Mr. Kowalski from the Chesapeake Bay Association expressed appreciation to the Board for their work and the opportunity to attend the meeting.

Ms. Moore from the Virginia Farm Bureau noted that she looks forward to working with the Ad Hoc Subcommittee addressing the baseline technical assistance allocation.

Mr. Tillman, from NRCS conveyed greetings from NRCS Chief Matthew Lohr.

ASTC-Programs

EQIP, CSP, RCPP and Easement Programs

Environmental Quality Incentive Program (EQIP)

Our EQIP allocation is \$24,686,250.00. We received 1,146 applications requesting \$44 million in Financial Assistance. Preapprovals of 522 applications is complete and obligation of landowner contracts is underway.

Conservation Stewardship Program (CSP)

On Friday, April 5th, NRCS announced the application period for CSP. Applications are due May 10th. This program changed from an acre-based program under the 2014 Farm Bill to a monetized-program in the new 2018 Farm Bill. Additionally, the 2018 Farm Bill authorized higher payments rates for certain activities including 125 percent for cover crops and resource conserving crop rotations and 150 percent for advanced grazing management activities.

Signups are underway for RCPP projects with VMRC, TNC, Franklin County Extension and Sustainable Chesapeake. Blaine Delaney recently retired and our new RCPP program manager is Stacey Bradshaw.

We are currently awaiting the new Announcement for Program Funding for the revised and expanded RCPP program under the 2018 Farm Bill. We have held many meetings over the last several weeks with partners who have expressed interest in the new program.

Agricultural Conservation Easement Program (ACEP)

We received 6 ALE applications for easements on 1,335 acres for nearly \$3 million and 2 WRE applications for approximately 65 acres and ranking us underway. We received 1.2 Million to allocate to high ranking applications.

Conservation Innovation Grants (CIG)

We just released the Notice of Funding Opportunity for CIG and proposals are due May 20th. The priorities for FY19 are soil health, grazing land/livestock health, innovation in high tunnel technologies and Treatment Measures to address the in-stream loading of excess Nutrients and Sediment from Legacy Sediments trapped by Historic Millpond Dams. Blaine Delaney recently retired, and our new CIG program manager is Stacey Bradshaw.

State Technical Committee Meeting

The second State Technical Committee Meeting of the fiscal year is scheduled for June 27th at the NRCS State Office in Richmond.

Wetland Reserve Program (WRP)

Construction for the Elmwood WRP restoration in Area 1, Culpeper County is complete.

Dam Rehabilitation

- **Mountain Run 11** Work was suspended in late January due to weather. All of the concrete work is complete. It is anticipated that work will resume in mid-April. There is about 4 weeks of work including structural earthfill, final site grading and stabilization remaining to complete the project.
- Mountain Run 50 Work was suspended in late January due to weather. It is anticipated that work will resume in late March. There is about 1 week of work including final site grading and stabilization remaining to complete the project.
- Upper North River 77 Construction has started. Excavation of Tilman Road and portions of the embankment and processing rocky material is underway. Work is scheduled to be completed in mid-September 2019.
- Cherrystone Creek 1 and Cherrystone Creek 2 The Final plan for Cherrystone Creek 1 is complete and the next step is for the Sponsor to sign the Plan. The Final plan for Cherrystone Creek 2A is complete and will be sent to NHQ for review soon.
- Johns Creek 1 The Sponsors selected a Recommended Alternative. The final Draft Plan is being developed with Sponsor input and will be sent to the NWMC for review in April.

State Resource Conservationist (SRC)

Customer Service/Outreach/Training

- Helped train, coordinate, and facilitate 33 NRCS and partnership outreach and training events this
 fiscal year where over 1994 participants attended. These training/outreach events strive to
 strengthen and expand NRCS partnership activities to achieve common goals. Some examples of
 the events:
 - Competed the JED trainings for all 4 Areas Approximately 100 NRCS/SWCD staff in attendance to learn the added links and notes on the CPA-52 which will provide helpful tools to properly document the special environmental concerns.
 - Led planning of and conducted the Jan 10 Area 4 JED using innovative partnership approach on ENM RCPP Program.
 - Planned, coordinated and conducted the January JED's (VFGC Winter Conferences) for Areas I, II, and III providing our field staff timely technical information to directly support implementation of Farm Bill Programs where 81 NRCS Conservation Planners from around VA were able to attend, learn and earn 3.0 CEU's for their nutrient management certification.
 - Partnered with VFGC, VA Tech, Virginia Cooperative Extension, Chesapeake Bay Foundation and Southern SARE to provide training to 28 agricultural professional employees at the 2-day intensive grazing school held at the Southern Piedmont AREC in Blackstone. Participants learned advanced principles of pasture and grazing management, developed hands on skills for using temporary fencing equipment for pasture allocation and completed an applied field exercise including pasture system evaluation, resource concern identification and recommendations for improvement along with a grazing plan layout map where participants had the opportunity to earn 6 nutrient management recertification credits and 8 certified conservation planner contact hours for DCR recertification.
 - Partnered with VFGC, Extension, SWCD and Black Diamond RC&D to conduct an
 educational meeting and pasture walk on the economic and soil health benefits of stockpiling
 and strip grazing fescue. Attendees were able to earn 2.0 Nutrient Management
 Recertification credits and a total of 33 people attended.
 - Worked with VANTAGE and Verona NRCS Office in selecting VANTAGE/NRCS 2019 No-Till Champion Award recipient.




- The South West LiDAR acquisition shown above is now available.

Minority Farmer Recognition. Submitted Virginia grazier Albert McGhee for inclusion in *Minority Landowner* magazine's "Farmers of the Year" issue. (McGhee was selected as the 2018 Civil Rights Advisory Committee Farmer of the Year.)

Soil Health. CIG. Highlighted Virginia Dare SWCD CIG grant (Southeast Virginia Farmers' 20/20 Club: Innovative Motivation in Conservation through Collaboration, Education and Implementation) during a farm tour for Chief Lohr on March 15. Seven club members representing a cross section of Chesapeake and Virginia Beach producers were invited to attend and offer their perspectives on experimenting with conservation practices that increase yield. (Chief Lohr travelled to Virginia Beach to speak at the Virginia Excellence in Ag event on March 14.)

Winter Meetings. Networked and shared program information with 1,500+ attendees of 5 major farm shows: Virginia Farm to Table Conference, Virginia Biological Farming Conference, Virginia Forage and Grassland Council Winter Forage Conferences, Virginia Farm Show, and Virginia No-Till Alliance Conference.

Report to the Virginia Soil and Water Conservation Board

April 24, 2019

Administrative Updates

- Dan Goerlich has been appointed as the VCE Associate Director for Economy, Community, and Food.
- Central District Director interviews were held April 11 and 12, 2019. Central District has fulltime ANR Extension agent vacancies in Goochland, Franklin, and Charlotte Counties, but none of these vacancies currently impact local SWCD appointments.
- The Associate Director of Field Operations and District Directors developed a hiring plan for Extension agent positions from Summer/Fall 2018 through Summer 2019 using existing resources. This hiring plan included 4-H, FCS, and ANR agent positions. ANR positions included: King William / King and Queen, Orange, Suffolk, New Kent, Spotsylvania, and Bland. Bland was subsequently filled by an internal transfer from Wythe County.

Selected Program Updates

- VCE provides educational programming to enable over 30,000 agricultural producers and pest
 managers to maintain certification in 27 pesticide applicator categories. In 2018, Extension
 agents hosted 120 trainings to recertify 2,624 private applicators. Trainers were prepared to do
 so by attending the 26th annual Virginia Pesticide Safety Educators Workshop. In addition,
 Virginia Tech Pesticide Programs hosted 16 online courses to prepare applicators for
 certification with 257 individuals enrolled.
- In 2018, Healthy Virginia Lawns (HVL) had 223 volunteers serving 1,000 clients, contributed 1,060 nutrient management plans covering 291.5 acres. Volunteers contributed 4,077 hours valued at \$112,117. DCR was instrumental in contributing funding that helped make this program possible from 2013 to 2018.
- VCE has been involved in brainstorming conversations with the Deputy Secretary of Natural Resources regarding how existing VCE educational programs may have positive outcomes for the Chesapeake Bay, and how to capture these programmatic outcomes.
- Southern Pasture and Forage Crop Conference will be held May 21 through 23 in Roanoke, VA.
