- II. <u>Approval of Minutes</u> On a motion by Mr. Jiulianti, seconded by Mr. Hoang, the minutes of the March 14, 2017 Board of Directors Meeting were unanimously approved. Voting aye: Chairman Letts, Mr. Jiulianti, Mr. Hoang, Mr. Smith and Ms. Aylor. Voting no: None.
- III. <u>Industrial Development Bond Program Applications</u> Taxable Bond (QECB) and 501(c)(3) Tax-Exempt Bond
 - A. Virginia SAVES Green Community Program, Inc. Richmond City \$1,665,320 Ms. Mary Jo Sisson-Vaughan presented this application to the Board. Mr. Montgomery reviewed the project and Mr. Lamb provided financing information. On a motion by Mr. Hoang, seconded by Mr. Smith, the Board unanimously approved the resolution authorizing the issuance of QECB taxable bonds to VA SAVES to finance the clean energy project for Gordonsville Holdings, LLC. Voting aye: Chairman Letts, Mr. Hoang, Mr. Smith, Ms. Aylor, and Mr. Jiulianti. Voting no: None.

B. Virginia United Methodist Homes, Inc. - Henrico County - \$55,000,000. Ms. Sisson-Vaughan reviewed this request for the Board. Mr. Chris Henderson and Mr. Kevin Salminen of Virginia United Methodist Homes were available to answer any questions. On motion by Mr. Jiulianti, seconded by Ms. Aylor, the Board of Directors unanimously approved the final resolution authorizing the issuance of tax-exempt bonds to finance the expansion, renovation, and refinance of existing debt. Voting aye: Chairman Letts, Mr. Jiulianti, Ms. Aylor, Mr. Smith, and Mr. Hoang. Voting no: None.

IV. Economic Development Loan Fund Application

- A. IDA of Pulaski County Pulaski County \$3,000,000. Ms. Gilbert presented this application to the Board. Mr. Michael Solomon of Pulaski County IDA, Mr. Tim Stuller from the Virginia Economic Development Partnership, and Mr. Carlos Tapias and Mr. James Kyanka of Phoenix Packaging, discussed the project and answered questions from the Board. On a motion by Mr. Smith, seconded by Mr. Hoang, the Board of Directors unanimously approved a \$3,000,000 10-year loan through the Economic Development Loan Fund to finance the construction and expansion of an existing 300,000 square foot manufacturing facility for Phoenix Packaging. Voting aye: Chairman Letts, Mr. Smith, Mr. Hoang, Mr. Jiulianti, and Ms. Aylor. Voting no: None.
- V. <u>Board Review and Ratification of Loans Approved/Declined by Staff</u> On a motion by Mr. Jiulianti, seconded by Mr. Smith, the Board of Directors ratified the March 2017 loan decisions made by staff. - A. Watkins Nurseries Ms. Sisson-Vaughan updated the Board and those in attendance on the status of VSBFA's \$750,000 EDLF loan commitment to Watkins Nurseries and explained that the loan will not close since the borrower could not meet the terms of VSBFA's commitment letter.
