## VI. Tax-Exempt Bond

a) Ms. Mackley presented with Ms. Korall, and Messrs. Ghannam, Graff, Inskeep, Shea, and Thorne the Pure Salmon Virginia LLC Interim Resolution authorizing and remarketing of previously tax-exempt \$125,000,000 environmental facilities revenue bond series 2022.

#### VII. Loan Guaranty Program and Economic Development Loan Fund Request
