Catherine Sprinkle, Speech-Language Pathologist

The Board met in accordance with a Notice of Formal Hearing dated August 29, 2023. Ms. Sprinkle appeared before the Board for the Formal Hearing and was represented by Nora Ciancio, Esq. The Board received evidence from the Commonwealth and from Ms. Sprinkle and her counsel regarding the allegations in the Notice.

CLOSED SESSION:

Dr. Wallace-Davis moved that the Committee convene a closed meeting pursuant to § 2.2-3711(A)(16) of the Code for the purpose of consideration and discussion of medical records of Patient A that are excluded from the Freedom of Information Act by § 2.2-3705.5 of the Code. Additionally, Dr. Wallace-Davis moved that Ms. Sprinkle, along with her attorney Ms. Ciancio, Ms. Joseph, Ms. Knachel, and Ms. Booberg attend the meeting because their presence in the closed meeting was deemed necessary. The motion was seconded by Mr. Wells and carried unanimously.

RECONVENE:

Dr. Wallace-Davis moved that the Committee certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded by Mr. Wells and carried unanimously.

The Committee reconvened in open session pursuant to § 2.2-3712(D) of the Code.

CLOSED SESSION:

Dr. Wallace-Davis moved that the Board convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia ("Code") for the purpose of deliberation to reach a decision in the matter of **Catherine Sprinkle**, **Speech-Language Pathologist**. Additionally, she moved that Ms. Knachel, Ms. Booberg, and Ms. Pote attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Board in its deliberations. The motion was seconded by Ms. Vencill and carried unanimously.

RECONVENE:

Dr. Wallace-Davis moved that the Board certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed

seconded by Dr. Rose and carried unanimously.

this quorum of the Board.
