**TIHESA N. ELLIOTT**  
Registration No. 0230-014828

A formal hearing was held in the matter of Tihesa N. Elliott following the summary suspension of her pharmacy technician registration on September 24, 2014, to discuss allegations governing the practice of pharmacy technicians in Virginia.

Ms. Elliott was not present at the hearing. The Board proceeded with the hearing in Ms. Elliott's absence as the Notice of Hearing dated September 24, 2014, was mailed to her legal address of record, both by regular and certified mail. Ms. Shinaberry ruled that adequate notice was provided to Ms. Elliott.

Corie Tillman Wolf, Assistant Attorney General, prosecuted the case with the assistance of Anne Joseph, Deputy Director, APD.

Ray Hernandez, Pharmacist in Charge, Walgreens Pharmacy #04616; Richie Waddell, Walgreens District Loss Prevention Manager; and John Turner, DHP Senior Investigator, testified on behalf of the Commonwealth.

Mr. Cox was not present at the hearing. The Board proceeded with the hearing in Mr. Cox' absence as the Notice of Hearing dated September 24, 2014, was mailed to his legal address of record, both by regular and certified mail. Ms. Shinaberry ruled that adequate notice was provided to Mr. Cox.

A formal hearing was held in the matter of Everette G. Richardson to discuss allegations that he may have violated the January 3, 2013 Order and certain laws and regulations governing the practice of pharmacy technicians in Virginia.

The Board proceeded with the hearing in Mr. Richardson's absence as the Notice of Hearing dated October 6, 2014, was mailed to his legal address of record, both by regular and certified mail. Decision:


