## CALL TO ORDER AND INTRODUCTIONS:

The scheduled quarterly meeting of the Virginia Apprenticeship Council was called to order by Chairman Barry W. Baker. The presence of a quorum was established.

Council Members introduced themselves. Staff members introduced themselves.

Chairman Baker congratulated Commissioner Davenport on his recent appointment by Governor Warner to serve on the State Hazardous Materials Emergency Response Advisory Council.

"I move to endorse the strategy as proposed by Counsel in closed session."

Mr. Whitaker seconded the motion. The motion was approved unanimously by role call vote.

# **Virginia Community College System:**

Mr. Bill Mercer and Dr. John Sygielski, VCCS, addressed the Council. Dr. Sygielski reported that due to budget cuts some programs were restructured including apprenticeship. Mr. Mercer would be Dr. DuBois's representative to the Council.

Commissioner Davenport asked Dr. Sygielski if there would be any reductions in the number of Apprenticeship Related Instruction Coordinators. Dr. Sygielski responded in the negative.

# U.S. Department of Labor, Bureau of Apprenticeship Training:

Mr. James Walker, USDOL, BAT State Director addressed the Council. Mr. Walker brought greetings from the Regional USDOL, BAT Director and the National Administer. Mr. Walker commented on the cooperation between the Program Office and his office.

# Department of Labor and Industry, Apprenticeship Program:

Ms. Jennifer Nolen, Apprenticeship Program Director reported that there were 11,267 active apprentices and 1,948 active sponsors to date.

# **Department of Labor and Industry:**

Commissioner Davenport began by expressing his appreciation to Mr. Jim Walker.

Commissioner Davenport reported that the Agency had hosted 16 delegates from the Peoples Republic of China on December 17, 2002. The delegation came to learn how apprenticeship worked in Virginia and they would visit only the states of Virginia and California.

The report concluded with the Commissioner thanking all of the Council members for their time, energy, and efforts in the support of apprenticeship.
