Call to Order / Welcome and Introductions

Chair Conlin called the meeting to order. A roundtable of introductions took place. Quorum was met.

Adoption of Agenda

Mark Roane moved to adopt the proposed agenda; Christine Appert seconded the motion, and the motion passed unanimously.

Adoption of March 2022 Meeting Minutes

Rachel Rounds moved to adopt the March 11, 2022, SRC Quarterly Meeting minutes as presented. Milford Stern seconded the motion, and the motion passed unanimously.

Public Comment

Mr. Sorey thanked DBVI for what the agency does and is delighted that the public can now join the SRC Quarterly meetings virtually. Mr. Sorey commented on the appointment of the new DBVI Commissioner.

Commissioner's Report – Commissioner Rick Mitchell

Written report provided. Additional comments are as follows.

In February, the Agency conducted a climate survey of all employees and received excellent feedback. The survey returned a high number of responses indicating 96% of staff feel they understand the mission of the Agency. The major takeaway from the survey addresses communications. In response to that, the Agency now has a Director of Communications and is publishing a monthly newsletter to be distributed to Council members, the Board, the public, the Agency stakeholders and staff. DBVI will continue to welcome feedback.

The Virginia General Assembly passed a two-year state budget June 1 and is now awaiting the Governor's signature.

Deputy Commissioner's Report – Dr. Rick Mitchell

Written report provided. Additional comments are as follows.

Recruitment for the Deputy Commissioner for Services position has begun and interviews will be conducted later in June. The Agency is recruiting for several vacancies including Education Coordinators, a part-time Rehabilitation Technology Specialist, a Rehabilitation Engineer, a Rehabilitation Teacher, and an Access Technology Instructor. A Coordinator for Engagement is a new position focusing on pre-employment transition, will report to Megan Hall, the Assistant Director for Vocational Rehabilitation and can be located at any one of DBVI's six regional offices.

VR Program Update – Pam Cato

Written report provided. Additional comments are as follows.

Ms. Cato explained the launch of a pilot with VCU-Rehabilitation Research and Training Center to provide a Pre-ETS Peer Mentoring Capacity Building Project which will provide real world transition experience, not just classroom instruction.

There are several summer programs about to begin.

Leap into Linux, June 26 – July 1, 2022, a one-week residential academy that teaches cyber security and citizenship.

Virtual Cyber Warriors offers five different trainings this summer starting June 20. The instructor, high school student Ishan Jadhwani, was recently highlighted in a NOVA newspaper as a leader and mentor in the field. The five offerings include Robotics, Digital Automation, Virtual Reality Metaverse, Cyber Threat Hunting, and Drones.

July 10 - August 12, 2022 is the Live Independent Feeling Empowered ("LIFE") program which is a five-week residential training program for students between the ages of 14-18 years old, providing basic training in the skills of blindness and advocacy skills.

The JMU Success! Program will begin with a group of applicants from throughout the state coming to JMU for a college immersion program in July.

The Parents Resource weekend will offer parents resources, information and a community of others who parent a blind or low vision individual. Parents Resource Weekend will be held on July 22 - 24 in Harrisonburg, VA at the Hotel Madison.

Business Relations Presentation

The Business Relations Team, Cindy Roberts, Diane McBride, and Karen Kahn, shared the best practices that came about due to the Covid-19 pandemic in regard to virtual meetings and networking. Many of the ways of virtually connecting with career seekers and business partners during the pandemic worked so well, they will continue to be conducted. Many of the career seekers' success stories were shared. DBVI's Business Relations Team has a presence nationally and many of its programs are getting national attention. "Celebrating Ability in the Workplace" in honor of National Disability Employment Awareness Month will be held October 5, 2022. This is DBVI's annual awards ceremony where the Agency honors its business partners and career seekers who have displayed excellence in hiring and those that have excelled within the workplace.

At the March 2022 SRC meeting Rachael Rounds, Chanthen Nene and Alexa Bowe volunteered to review Hearing Officer applications. There has been a delay in this review, and volunteers will be notified when the review is scheduled.
