Comments from the Commissioner – Dr. Avula provided local, state, and federal updates.

COMMENT PERIOD

Mr. Dearborn provided comments on the Child Support Family Engagement Program and expressed his gratitude for his caseworker Lisa Smith.

There were no comments from boards and directors of community action agencies.

Comment from the Virginia League of Social Service Executives — Rebecca Morgan, President Ms. Morgan shared unwinding is at the top of the agenda for all local departments. She spoke about the trauma reaction to the media and its impact on day-to-day moral and functionality. The League is having a media relations training at the upcoming conference in May. The League is in collaboration with VDSS in making the replacement VACMS system their top legislative priority. She shared that her continued focus on improving communication internally with the local departments and with the state doing a tremendous amount of advocacy going forward.

Kimberly Ayers, Chair, Child and Family Services Committee, shared April is child abuse prevention and awareness month. In January 2023, the Child and Family committee identified seven main areas with four that at the top. They include alternative living arrangements and court room size; relative and fictive kin subsidy payments; increased payment rates for high priority placements; and resource parents. She shared DSS has been very responsive the League on these priorities. She thanked Commissioner Avula for his leadership and team collaboration.

Erik Johnston, Executive Director, VA Community Action Partnership, provided updates on the work of Virginia's 31 community action agencies. Many community action agencies are partnering with VA DHCD on the Commonwealth's broadband opportunity planning efforts. These regional plans will be submitted in the summer and help inform the state's overall plan on ways to increase access and adoption efforts. VACAP has joined the Virginia Funder's Network to increase partnerships between community action agencies and philanthropy. VACAP appreciates the bipartisan support of proposed increases during the General Assembly for the Volunteer Income Tax Assistance network. VACAP is partnering with VDSS on leadership training and peer groups for CAA leaders and frontline workers. May is Community Action Month and VACAP will be hosting regional meetings throughout the month. VACAP will hold its second annual Summit on October 10-11 in Richmond.
