Ms. Nosbisch stated there was a NCEES Board Administrators meeting on July 29th. Professional

The NCEES annual meeting on August 19-20th has been cancelled. There was a virtual NCEES State of the Council meeting on September 8th and the annual virtual Business Session was moved to September 15th. Mr. Allen will be the voting delegate and he, Mr. Kelly and Ms. Nosbisch will be attending the virtual meeting.

Ms. Nosbisch stated she appreciates the Land Surveyors efforts on the State Specific Exam. She stated Mr. Allen has been appointed to the NCEES Exam Audit Section Update Committee. The Virginia Association of Surveyors Convention is September 14-18th. Ms. Nosbisch and the Land Surveyors will provide a presentation on September 17th from 1-3pm.

Ms. Nosbisch was assigned to the NCARB Diversity Workforce Collaborative which met on August 12th. She also participated in a Diversity Focus Group on September 1st. Due to increasing COVID numbers, the NCARB Region 2 Student Educator Practitioner scheduled for October 14-15th has been rescheduled to September 29-30, 2022. Ms. Nosbisch informed the Board the NCARB transition to PSI will begin in early 2022 and there will be a remote testing option.

Ms. Nosbisch stated that CIDQ will be allowing remote proctoring in the fall for the IDFX and the IDPX exam sections. They have been collecting race and ethnicity on applicants to increase efforts of diversity. They have also been working with an inter-organizational task force to develop recommendations for collective DEI actions for the interior design profession. The CIDQ annual meeting is November 12-13th and attendees have an in-person or virtual option. Requests will be submitted for Ms. Stiles and Ms. Alexander to attend the meeting virtually.

Ms. Nosbisch stated that the new regulations were effective September 2, 2021. She stated the proposed fee increase NOIRA is still in process. Ms. Broz-Vaughan stated that due to marijuana conviction changes in legislation, the language in the new regulations needs to be adjusted to exclude misdemeanor marijuana drug convictions and this can be accomplished by an exempt regulatory action if filed within 90 days of enactment.. Mr. Stone moved that an exempt action be filed to make the necessary changes. Mr. Zmuda seconded the motion which was unanimously approved by: Alexander, Allen, Anglin, Colley, Drake, Kelly, Price, Reynes, Stokes, Stone, and Zmuda.

ics tor discussion iee (LA" I am writing you on behalf of the Landscape Architects Technical Committee (LATC) to encourage the Council of Landscape Architectural Registration Boards (CLARB) to consider the following comments regarding the Uniform Standards that were introduced during the CLARB Regional meetings on August 12, 2021.

The standards identify two pathways to licensure; one with a Landscape Architectural Accreditation Board (LAAB)/Landscape Architecture Accreditation Council (LAAC) accredited landscape architecture degree, 2 years of experience, and passage of the Landscape Architect Registration Examination (LARE); and the second pathway presented as 8 years of experience which can include other educational certification/institutions up to two years and passage of the LARE. The second pathway would be more restrictive than California's proposed 6 years of experience for an experience-only pathway. Furthermore, CLARB's uniform procedures recommend allowing candidates with an accredited degree to sit for all sections of the LARE prior to obtaining practical experience, a procedure California strongly opposes. The experience component exposes candidates to the breadth of the profession and important health, safety, and welfare issues. LATC feels that experience prior to examination supports competency, reduces potential liabilities and ultimately increases public protection.

During their August 4, 2021 meeting, LATC further discussed proposed CLARB Uniform Standards Options with a focus on identifying possible discrepancies between the proposed options and existing California law. It was noted that all four options announced by CLARB at that time, do not align with existing California law which requires candidates to document qualifying education and/or training experience credit and obtain pre-approval by the LATC prior to sitting for any section of the LARE.

LATC would like to take this opportunity to remind CLARB and CLARB Member Boards of the current examination prerequisites of California. California candidates must verify at least two years (3,000 hours) of qualifying training experience credit as outlined in California Code of Regulations section 2620 (Education and Training Credits) prior to sitting for LARE sections 3 (Design) and 4 (Grading, Drainage and Construction Documentation).

18VAC10-20-10. Definitions.

Section 54.1-400 of the Code of Virginia provides definitions of the following terms and phrases as used in this chapter:

Architect

Board

Certified interior designer

Interior design. When used in this chapter, interior design shall only be applicable to interior design performed by a certified interior designer.

oposot official bi s chart Land surveyor. When used in this chapter, land surveyor shall include surveyor photogrammetrist unless stated otherwise or the context requires a different meaning.

Landscape architect

Practice of architecture

Practice of engineering

Practice of land surveying

Practice of landscape architecture

Professional engineer

The following words, terms, and phrases when used in this chapter shall have the meanings ascribed to them except where the context clearly indicates or requires different meanings:

"Application" means a completed application with the appropriate fee and any other required documentation including references, experience verification, degree verification, and verification of examination and licensure or certification.

"Comity" means the recognition of licenses or certificates issued by other states or other jurisdictions of the United States as permitted by § 54.1-103 C of the Code of Virginia.

"Department" means the Department of Professional and Occupational Regulation.

"Direct control and personal supervision" means supervision by a professional who oversees and is responsible for the work of another individual.

"Good moral character" may be established if the applicant or regulant:

1. Has not been convicted of a non-marijuana misdemeanor in the last 10 years or has ever been convicted of a felony that would render the applicant unfit or unsuited to engage in the occupation or profession applied for in accordance with § 54.1-204 of the Code of Virginia;

2. Has not committed any act involving dishonesty, fraud, misrepresentation, breach of fiduciary duty, negligence, or incompetence reasonably related to:

a. The proposed area of practice within 10 years prior to application for licensure, certification, or registration; or

Ob. The area of practice related to licensure, certification, or registration by the board while under the authority of the board;

3. Has not engaged in fraud or misrepresentation in connection with the application for licensure. certification, or registration, or related exam;

4. Has not had a license, certification, or registration revoked or suspended for cause or been disciplined by the Commonwealth or by any other jurisdiction, or surrendered or has surrendered a license, certificate, or registration in lieu of disciplinary action; or

5. Has not practiced without the required license, registration, or certification in the Commonwealth or in another jurisdiction within the five years immediately preceding the filing of the application for licensure, certification, or registration by the Commonwealth.

"Good standing" means that the regulant holds a current or active license, certificate, or registration issued by any regulatory body that is not subject to a current sanction. The regulant shall be in good standing in every jurisdiction where licensed, certified, or registered.

"Place of business" means any location that, through professionals, offers or provides the services of

architecture, engineering, land surveying, landscape architecture, interior design, or any combination thereof. A temporary field office established and utilized for the duration of a specific project shall not qualify as a place of business under this chapter.

"Profession" means the practice of architecture, engineering, land surveying, landscape architecture, or interior design.

"Professional" means an architect, professional engineer, land surveyor, landscape architect, or certified interior designer who holds a license or certificate issued by the board pursuant to the provisions of this chapter and is in good standing with the board to practice his profession in the Commonwealth.

"Registrant" means a business holding a registration issued by the board and in good standing to offer or provide one or more of the professions regulated by the board.

"Regulant" means an architect, professional engineer, land surveyor, or landscape architect holding a license issued by the board and is in good standing; a certified interior designer holding a valid certification issued by the board and is in good standing; or a registrant.

"Resident" means physically present at the place of business a majority of its operating hours.

"Responsible person" means the professional named by the registrant to be responsible and have control of the registrant's regulated services offered, rendered, or both. A professional can only be the responsible person for the profession indicated on his licenses or certifications.

"Surveyor photogrammetrist" means a person who by reason of specialized knowledge in the area of photogrammetry has been granted a license by the board to survey land in accordance with Chapter 4 (§ 54.1-400 et seq.) of Title 54.1 of the Code of Virginia for the determination of topography, contours, or location of planimetric features using photogrammetric methods or similar remote sensing technology.

18VAC10-20-790. Sanctions.

A license, certificate, or registration shall not be sanctioned unless a majority of the eligible voting members of the entire board vote for the action. The board may discipline or sanction any regulant if the board finds that:

1. The regulant failed to maintain good moral character pursuant to the definition in 18VAC10-20-10;

2. The license, certification, or registration was obtained or renewed through fraud or misrepresentation;

3. The regulant has been found guilty by a court of competent jurisdiction of any material misrepresentation in the course of professional practice or has been convicted, pleaded guilty, or has been found guilty, regardless of adjudication or deferred adjudication, of any felony or <u>non-marijuana</u> misdemeanor that, in the judgment of the board, adversely affects the regulant's ability to perform satisfactorily within the regulated discipline. The board shall review the conviction pursuant to the provisions of § 54.1-204 of the Code of Virginia;

4. The regulant has committed acts constituting professional incompetence, negligence, or gross negligence;

5. The regulant has abused drugs or alcohol to the extent that professional competence is adversely affected;

6. The regulant fails to comply, or misrepresents any information pertaining to their compliance, with any of the continuing education requirements as contained in this chapter;

7. The regulant violates any standard of practice and conduct as defined in this chapter;

8. The regulant violates or induces others to violate any provision of Chapters 7 (§ 13.1-542.1 et seq.) and 13 (§ 13.1-1100 et seq.) of Title 13.1 or Chapters 1 (§ 54.1-100 et seq.) through 4 (§ 54.1-400 et seq.) of Title 54.1 of the Code of Virginia, or any other statute applicable to the practice of the professions regulated by this chapter;

9. The regulant has been disciplined by any county, city, town, state, or federal governing body. For purposes of this section "discipline" means reprimand; civil or monetary penalty; probation, suspension, or revocation of a license; or cease and desist order. The board will review such discipline before taking any disciplinary action of its own; or

10. The regulant fails to notify the board within 30 days of having been disciplined by any county, city, town, state, or federal governing body as stipulated in subdivision 9 of this section.
