CALL TO ORDER: A Special Conference Committee of the Board of Physical Therapy was called to order at 2:54 p.m.

DISCUSSION: Mr. Lucy did not appear before the Committee in accordance with the Notice of the Board dated July 16, 2013, nor was he represented by counsel.

CLOSED SESSION: Upon a motion by Mr. Maroon, and duly seconded by Mr. Styron, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A(27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Glenn Lucy, PTA. Additionally, he moved that Ms. Helmick, Ms. Petersen and Mr. Egan attend the closed meeting

because their presence in the closed meeting was deemed necessary and would aid the Committee in its discussions. The Committee entered into closed session at 3:06 p.m.

RECONVENE:

Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session at 3:47 p.m.

DECISION:


Upon a motion by Mr. Maroon, and duly seconded by Mr. Styron, the Committee moved to place Mr. Lucy on Indefinite Probation of no less than two years of active employment as a Physical Therapist Assistant. The Committee issued a \$200.00 monetary penalty to be paid within 60 days of Order entry. Mr. Lucy is ordered to provide self reports to the Board as well as providing a statement allowing for unrestricted communication with his employers. Mr. Lucy shall inform his current physical therapy employer and each future physical therapy employer that the Board has placed him on probation and shall provide each employer with a complete copy of the current Board Order and the 2009 Board Order. Mr. Lucy is subject to other Terms and Conditions as provided for in the Order. The motion carried.

VOTE:

The vote was unanimous.

The Committee adjourned at 3:49 p.m.
