Kiana Natalia Inniss did not appear at the meeting in person, by counsel, or by any other qualified representative.

The members voting 'yes' were Mr. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, and Ms. Quinn. There were no negative votes. The motion passed unanimously.

Lynn Lowery

Upon a motion by Mr. R. Jones and seconded by Mr. Minor, the Board voted to accept the recommendation in the Summary of the Informal Fact-Finding Conference and approve Heather Lynn Lowery's license application.

The members voting 'yes' were Mr. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, and Ms. Quinn. There were no negative votes. The motion passed unanimously.

REPORTS

Mr. Kirschner provided the Board with an update on the status of examinations after six months with Professional Credential Services, Inc., including an overview of pass rates for various license types, and a discussion of the low pass rates for the master esthetician theory examination. Mr. Kirschner advised the Board that the master esthetician theory examination is under review by the vendor and the Director of Examinations, who will be consulting with subject matter experts to address the issue.

Examinations

Mr. Kirschner reported to the Board on regulatory actions that are currently underway, including the fast-track action to amend the regulations to allow esthetician and master esthetician instructors to teach waxing programs in cosmetology and waxing schools. Mr. Kirschner indicated that the regulations are currently in the Secretary of Commerce's office.

Regulatory Report

Mr. Kirschner also advised the Board that the Notice of Intended Regulatory Action (NOIRA) for tattoo and body-piercing regulations, approved by the Board at its May 8, 2017 meeting, has been submitted and is currently in the Governor's office for review.

Mr. Kirschner reported to the Board on the National-Interstate Council of State Boards of Cosmetology (NIC) annual conference, held August 2 - 8, 2017 in Charleston, West Virginia, and attended by Mr. Melis, Mr. Kirschner, and Board Member, Robert Jones.

NIC Conference Report

Mr. Kirschner indicated to the Board that some of the topics addressed at the conference included model cosmetology laws, fraudulent application activity, and the regulation of advanced techniques, such as microneedling and microblading across the states. Mr. Jones reported he was elected by the NIC as a District Representative for approximately seventeen states.

Mr. Kirschner provided a report to the Board of the Committee on Esthetics Apprenticeships, which met on June 28, 2017. The Committee received public comments and made amendments to the proposed Standards of Apprenticeship for the Esthetician and Master Esthetician Apprenticeship programs. The committee recommended adoption of the standards. The committee also discussed whether microneedling was within the scope of practice of an esthetician.

Esthetics Committee

Upon a motion by Mr. Quesenberry and seconded by Ms. LaPierre, the Board voted to approve the proposed Standards of Apprenticeship for submission to the Department of Labor and Industry for its review.

The members voting 'yes' were Mr. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, and Ms. Quinn. There were no negative votes. The motion passed unanimously.

Mr. Kirschner reported to the Board on the Barbering Committee Meeting that took place on June 12, 2017. Topics discussed by the Committee included consideration of two-tiered barber licensing to include a master barber license; transfer of student hours between schools and/or programs; the scope of practice of a licensed barber, as defined by the Code of Virginia; and the current barber curriculum and how it relates to the scope of practice. Mr. Kirschner advised the Board that these topics would be further addressed in the Old Business and New Business portions of the meeting.

Barbering Committee

Mr. Kirschner addressed the Board on the matter of the transfer of student hours, outlining the steps the Board had taken with its Guidance Documents, and explaining the reasons and impact of the policy.

OLD BUSINESS Transfer Hours

Mr. Kirschner addressed the Board on the legal definition of barbering, per the Code of Virginia, and with problems in the current barber curriculum as it pertains to the definition. Mr. Kirschner discussed recommendations made by the Barbering Committee to bring the curriculum in line with the definition of barbering and eliminate training and practices that are outside the scope of barbering. He then outlined three actions that would need to take place to effect the recommended changes:

(1) A fast-track regulatory action is recommended on barber curriculum, hours, and performances to bring the regulations in line with the scope of practice.

Upon a motion by Ms. LaPierre and seconded by Mr. R. Jones, the Board voted to initiate a fast-track regulatory action to amend the barber curriculum, hours, and performances, as recommended.

The members voting 'yes' were Mr. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, and Ms. Quinn. There were no negative votes. The motion passed unanimously.

(2) A Guidance Document addressing the barbering scope of practice as it relates to curriculum content, hours, and performances, is recommended.

Upon a motion by Ms. LaPierre and seconded by Mr. Minor, the Board voted to authorize staff to draft the recommended Guidance Document.

The members voting 'yes' were Mr. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, and Ms. Quinn. There were no negative votes. The motion passed unanimously.

(3) The barbering examination will need to be modified to remove the topics and performances that are outside the scope. Mr. Kirschner stated that the examination vendor has indicated it may take 60 to 90 days to make the changes to the examinations.

After discussion by the Board and acknowledgment of the Board members not in attendance, a motion was made by Ms. McCaffrey and seconded by Mr. Minor to postpone the planned Board elections until the November 6, 2017 meeting.

ELECTIONS

The members voting 'yes' were Mr. Jones, Ms. LaPierre, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, and Ms. Quinn. There were no negative votes. The motion passed unanimously.

Mr. Kirschner provided a brief overview of board meeting quorum and voting requirements.

IN-SERVICE TRAINING

There being no further business to be brought before the Board, Mr. Quesenberry adjourned the meeting at 11:23 a.m.
