SUMMARY OF MEETING

After the roll call and a quorum be declared, Dr. Harp provided the emergency egress instructions.

Dr. Harp stated that the purpose of the meeting was to satisfy the requirement of SB1045 which states "That the Board of Medicine shall post information about autism spectrum disorder developed by the Board together with the Department of Behavioral Health and Developmental Services and other stakeholders, including information about diagnosis of autism spectrum disorder in adults and children, the role of health care providers in identifying and diagnosing autism spectrum disorder in adults and children, services available to adults and children with autism spectrum disorder in the Commonwealth, processes and procedures for linking adults and children with autism, and other sources of information on topics related to the identification, diagnosis, and treatment of autism spectrum disorder in adults and children on a website maintained by the Board, and shall notify licensees regarding the availability of such information."

After the committee members introduced themselves, Ms. Evanko moved to approve the agenda as presented. The motion was seconded and carried unanimously. There was no public in attendance.

The Committee discussed the history of the bill, and all agreed that whatever information is

provided that is should be concise and factual, and should capture the letter and spirit of the law.

While considering the links, Ms. Yeatts and Ms. Deschenes impressed upon the Committee that providing any perception of the endorsement of specific resources is outside the scope of the responsibility of the Board of Medicine, as the Board does not attempt to advise people on their practice or guide physicians to better practices or diagnosis. Ms. Yeatts stated that this is a unique situation and there is not a level of comfort about the role of the Board providing expertise.

The members agreed that the links should be limited to state and federal only and after review of the 47 links submitted for consideration, the following 7 were selected.
