Mr. Fletcher moved to approve the draft language and to recommend it to the full Board of Medicine for consideration. Dr. Harp informed the Advisory Board that this item would be on the Board of Medicine's agenda for February 19th.

3. VABA Press Release for 1000 Licensed Behavior Analysts

Ms. Bethune discussed with the Advisory Board the intention of the Virginia Association for Behavior Analysis (VABA) to prepare a press release when the number of licensed behavior analysts and assistant behavior analysts reaches one thousand. Dr. Harp said that it was preferable that such a release come from the VABA rather than the Advisory Board. No action was necessary.

Mr. Heaberlin informed the Advisory Board that there are currently 630 Behavior Analysts and 117 Assistant Behavior Analysts holding licenses issued by the Virginia Board of Medicine.
