## **APPROVAL OF MINUTES OF OCTOBER 8, 2015**

Ms. Corbatto moved to approve the minutes of October 8, 2015. The motion was seconded and carried.

#### ADOPTION OF AGENDA

Ms. Yeatts requested that regulatory actions be included, so item 1 was amended to Legislative and Regulatory Update. Ms. Corbatto Moved to approve the agenda as amended. The motion was seconded and carried.

## **PUBLIC COMMENTS ON AGENDA ITEMS**

#### **NEW BUSINESS**

## 1. Legislative and Regulatory Update

Ms. Yeatts informed the Advisory Board of bills of interest from the 2016 Session of the General Assembly. Ms. Yeatts additionally discussed with the Advisory Board the regulatory update for "Student Athletic Trainer" and public comment received. Ms. Yeatts informed the Advisory Board that the term "Student Athletic Trainer" is used in the Code of Virginia; therefore, changing the term "Student Athletic Trainer" to "Athletic Training Student" in the regulations would first require a change in the Code of Virginia. The Advisory Board took no action.

## 2. Oversight of Secondary AT Programs

Mr. Puglia led the Advisory Board in a discussion regarding oversight of secondary programs as it relates to best practices and decisions regarding return to play. Ms. Corbatto stated that Athletic Trainers have a legal responsibility to refer to a medical doctor, thus removing school administrators from the decision regarding return to play. No action was necessary.

## 3. Update of Professional and Industry Designations

Mr. Puglia informed the Advisory Board that NATABOC has shortened the acronym to BOC to avoid confusion with NATA, which is now a separate organization. The Advisory Board determined that no regulatory changes are required since the legal name is still NATABOC. No action was necessary.

#### **ANNOUNCEMENTS**

Mr. Heaberlin informed the Advisory Board that there are currently 1,338 Athletic Trainers who hold licenses issued by the Virginia Board of Medicine. Additionally, 213 licenses were issued within the last calendar year.
