- CALL TO ORDER:** A Special Conference Committee of the Board was called to order at 9:30 a.m.

- MATTER:** Shayma Al-Mudhafar, M.D. License No.: 0101-242652

- DISCUSSION:** Dr. Al-Mudhafar appeared before the Committee in person in accordance with a Notice of the Board dated March 7, 2016.
- The Committee fully discussed the allegations in the Notice with Dr. Al-Mudhafar
- CLOSED SESSION:** Upon a motion by Dr. Mackler, and duly seconded by Dr. Allison-Bryan, the Committee voted to convene a closed meeting pursuant to §2.2-3711.A (27) of the Code of Virginia, for the purpose of deliberation to reach a decision in the matter of Dr. Al-Mudhafar. Additionally, he moved that Ms. Deschenes and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations.
- RECONVENE:** Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and announced its decision.
- DECISION:** Upon a motion by Dr. Mackler, and duly seconded by Dr. Allison-Bryan, the Committee made certain findings of fact and

conclusions of law and voted to issue Dr. Al-Mudhafar a reprimand and subject her license to certain terms and conditions and a monetary penalty of \$2,000.


**VOTE:**

The vote was unanimous.

**ADJOURNMENT:**

The Committee adjourned at 11:45 p.m.

*As provided by law this decision shall become a Final Order thirty (30) days after service of such Order on Dr. Al-Mudhafar, unless a written request to the Board for a formal hearing on the allegations made against her is received from Dr. Al-Mudhafar, within such time. If service of the Order is made by mail three (3) additional days shall be added to that period. Upon such timely request for a formal hearing, the decision of the Special Conference Committee shall be vacated.*
