MATTER CONSIDERED: Craig C. Krause, M.D., License No.: 0101-233772

The Board received information from Adjudication Specialist Lori Pound in order to determine whether Dr. Krause's ability to practice medicine constituted a substantial danger to public health and safety. Ms. Pound provided details of the case to the Board for its consideration.

DECISION: On a motion by Dr. Edwards, and duly seconded by Dr. Miller, the Board determined that Dr. Krause's ability to practice constituted a substantial danger to the public health and safety and voted to summarily suspend his license simultaneous with the institution of proceedings for a formal administrative hearing pursuant to Section 54.1-2408.1 of the Code of Virginia.

VOTE: The vote was unanimous.

ADJOURNMENT: The Board adjourned at 6:35 a.m.

A formal hearing is scheduled for February 15, 2018, at 1:00 p.m. for a final determination regarding this pending matter.
