CLOSED MEETING: Dr. McDonough moved that the Special Conference Committee of the Board of Nursing convene a closed meeting pursuant to Section 2.2-3711(A)(27) of the *Code of Virginia* at 9:50 A.M. for the purpose of deliberation to reach a decision in the matter of Ms. Allison. Additionally, Dr. McDonough moved that Ms. Power and Ms. Joseph attend the closed meeting because their presence in the closed meeting is deemed necessary, and their presence will aid the Committee in its deliberations. The motion was seconded and carried unanimously.

Further, she shall be ordered to comply with all treatment recommendations. However, Ms. Parnell may be required to appear at an informal conference to consider the recommendations where the Board will make final disposition in this matter. The motion was seconded and carried unanimously.

An Order will be entered. As provided by law, this decision shall become a Final Order 30 days after service of such Order on Ms. Parnell, unless a written request to the Board for a formal hearing on the allegations made against her is received from Ms. Parnell within such time. If service of the Order is made by mail, three additional days shall be added to that period. Upon such timely request for a formal hearing, the Order shall be vacated.

The Committee reconvened in open session at 3:10 P.M.

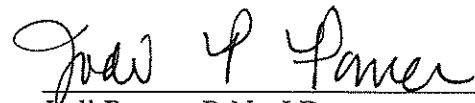
