- 3. Ensure that the annual passage rates for the NCLEX for the past five years are posted [18VAC90-20-110.]; and
- 4. Limit enrollment to 30 students per year until the three faculty positions have been filled in compliance with [18VAC90-20-90.B.1.]

In addition, the Board will consider the NCLEX pass rate for 2014.
