Review and Consideration of Draft Guidance Document 90-63:

The Committee acknowledged their review of the second draft of Guidance Document 90-63 and staff recommendations. Ms. Douglas and Ms. Yeatts provided amendments and rationale for deleting references to Propofol to include:

- Propofol is not the only medication used in procedural sedation
- Board of Nursing law and regulations do not reference Propofol or any other medications specifically
- Public comments received earlier in the process recommended, specificity that is not appropriate for inclusion in a guidance document

Additional amendments to Guidance Document 90-63 were made in areas believed to be outside the scope of the Boards authority with respect to facility requirements and policies.
