At 10:24 a.m. Ms. Hershkowitz moved that this informal conference committee convene a closed meeting pursuant to Section 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation in the matter of Chester Career College, PN program, Chester. Additionally, she moved that Jodi P. Power, RN, JD, Deputy Executive Director, Anne G. Joseph, JD, MPA. Administrative Proceedings Division, Paula B. Saxby, RN. Ph.D., Deputy Executive Director, Charlette Ridout, Senior Nursing Education Consultant, and Beth Yates, Administrative Assistant attend the meeting as their presence is deemed necessary to aid the informal conference in its deliberations.

The motion was seconded and carried unanimously. The Committee reconvened in open session at 11:28 a.m.

Ms. Hershkowitz certified that the informal conference committee heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened.

Action: Recommend to withdraw approval of the practical nursing program at Chester Career College and order closure of the practical nursing program no later than December 31, 2017 with the following terms and conditions:

- 1. The approval of Chester Career College's PN program is WITHDRAWN.
- 2. Chester Career College shall close no later than December 31, 2017.

- 3. Chester Career College shall not admit any new students or transfer students.
- 4. Within 60 days of the entry of this Order, Chester Career College, PN program shall inform all current students regarding this Order.
- 5. All current students shall graduate or be transferred no later than December 31, 2017.
- 6. No student shall graduate without obtaining supervised direct client care clinical experience in maternal/infant nursing as required by 18 VAC 90-20-120(B)(1) of the Regulations, separate and apart from pediatric nursing.
- 7. Chester Career College PN program shall submit to the Board reports regarding its progress toward closure. The first report must be received in The Board office no later than 60 days from the date this Order is entered. Subsequent reports must be received quarterly by the last day of the months of March, June, September, and December until the program closes.

At 12:54 p.m. Ms. Hershkowitz moved that this informal conference committee convene a closed meeting pursuant to Section 2.2-3711(A)(27) of the *Code of Virginia* for the purpose of deliberation in the matter of Centura College, PN program, Norfolk. Additionally, She moved that Jodi P. Power, RN, JD, Deputy Executive Director, Anne G. Joseph, JD, MPA, Administrative Proceedings Division, Paula B. Saxby, RN, Ph.D., Deputy Executive Director, Charlette Ridout, Senior Nursing Education Consultant, and Beth Yates, Administrative Assistant attend the meeting as their presence is deemed necessary to aid the informal conference in its deliberations.

Action: Recommend to rescind the withdrawal of approval of Centura College Norfolk PN program and continue the program on conditional approval subject to the following terms and conditions:

1. Within 60 days of the entry of this Order, Centura College Norfolk PN program shall submit to the Board for review and approval a

new improvement and NCLEX success plan, including a plan for hiring qualified faculty and a plan for the enrollment of new students. Thereafter, Centura College Norfolk, PN program shall comply with its approved plan.

- Centura College Norfolk PN program shall provide reports demonstrating compliance with the terms and conditions of this Order every six months, with the first report due by August 1, 2017.
- 3. Centura College Norfolk PN program shall notify all current and prospective students of its approval status.
- 4. The NCLEX pass rate for first –time testers takers in Calendar Year 2018 shall be 80 percent or above.
- 5. Centura College Norfolk PN program shall comply with all of the Board's regulations for maintaining an approved practical nursing education program in Virginia.
- 6. The Board, at its discretion, may conduct site visits to determine Centura College Norfolk PN program compliance with this Order. Centura College Norfolk PN program shall be responsible for any fees that may be required for review and approval, including but not limited to those fees associated with survey and site visits.
- 7. After the results of the NCLEX passage rates for Calendar Year 2018 are made available, the Education Special Conference Committee will review Centura College Norfolk PN program compliance with this Order and further consider the approval status of Centura College Norfolk to operate a practical nursing education program.
- Any violation of the terms and conditions of this Order may constitute grounds for withdrawal of Centura College Norfolk's approval to operate a practical nursing program, and an informal conference shall be convened to determine whether approval shall be withdrawn.
