Mr. Critzer said if he can get a meeting Scheduled and it does not produce results then he thinks they should continue up the "chain of command" on this issue because these issues and the concerns voiced will not just go away. Mr. Critzer said that it is important that the system understands that some of these stipulations are clearly out of the control of OEMS because the FBI has identified the Virginia State Police as the responsible agent, and they have the responsibility of establishing regulation and policy. Mr. Critzer said he knows of one locality that is thinking of putting forth legislative changes to the current policy. Scott Winston said there may be several localities considering this option, as well.
