| | concerned about this. Northern Virginia had been doing one-for-one drug exchanges |
| | for at least 10 years. Questions were asked about what could be done to get this |
| | included in the regs. The next BOP meeting is March 26. Several pharmacists are on |
| | board with this and a letter will be circulated for their signatures in support of this. A |
| | few of the pharmacists will also attend the meeting and one is Jill Abernathy. She |

| | iii. <u>General Assembly activities</u> – HB1010 – Gary Critzer and Gary Brown gave brief updates on the bill. The Advisory Board met with the Chief from Bedford County back in November at symposium about recruitment and retention and EMS training. OEMS had agreed to discuss his concerns through the committee structure to avoid legislature, but that did not happen. This bill may return next year in its current form or in a different form. The Advisory Board Executive Committee discussed the recruitment and retention issues again at its meeting on January 27, 2014. We have a year |
| | HB581 & SB355 – These bills deal with cohesive language concerning rescue squad, lifesaving crew, scene emergency, etc. He wants the <i>Code of Virginia</i> to say the same thing all the way through. This will be discussed tomorrow at the Legislative & Planning Committee Meeting tomorrow. |
| | Mobile Integrated Healthcare Community Paramedicine – Virginia is a little behind the times on this. Discussions have been held and some of the doctors say they don't need another license to do this. The home health care and hospice organization says that a license is required to perform home health services. Michael stated that regulatory language may need to be drafted depending on what the Attorney General says about this. He expects a response within the next few days. |
